A bill to amend 1949 PA 300, entitled

"Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 602b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 602B. (1) A PERSON SHALL NOT READ, WRITE, OR SEND A TEXT
- 2 MESSAGE ON A WIRELESS 2-WAY COMMUNICATION DEVICE, INCLUDING A RADIO
- 3 TELEPHONE USED IN CELLULAR TELEPHONE SERVICE OR PERSONAL
- 4 COMMUNICATION SERVICE, WHILE OPERATING A MOTOR VEHICLE ON A HIGHWAY
- 5 OR STREET IN THIS STATE.
- 6 (2) SUBSECTION (1) DOES NOT APPLY TO AN INDIVIDUAL WHO IS
- 7 USING A DEVICE DESCRIBED IN SUBSECTION (1) TO DO ANY OF THE
- 8 FOLLOWING:
- 9 (A) REPORT A TRAFFIC ACCIDENT, MEDICAL EMERGENCY, OR SERIOUS
- 10 ROAD HAZARD.
 - (B) REPORT A SITUATION IN WHICH THE PERSON BELIEVES HIS OR HER

- 1 PERSONAL SAFETY IS IN JEOPARDY.
- 2 (C) REPORT OR AVERT THE PERPETRATION OR POTENTIAL PERPETRATION
- 3 OF A CRIMINAL ACT AGAINST THE INDIVIDUAL OR ANOTHER PERSON.
- 4 (D) CARRY OUT OFFICIAL DUTIES AS A POLICE OFFICER, LAW
- 5 ENFORCEMENT OFFICIAL, MEMBER OF A PAID OR VOLUNTEER FIRE
- 6 DEPARTMENT, OR OPERATOR OF AN EMERGENCY VEHICLE.
