December 1, 2007, Introduced by Rep. Hildenbrand and referred to the Committee on Tax Policy.

A bill to amend 1937 PA 94, entitled
"Use tax act,"
by amending section 3d (MCL 205.93d), as added by 2007 PA 93.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 3d. (1) The use or consumption of the following services
2 is taxed under this act in the same manner as tangible personal
3 property is taxed under this act:

4 (a) Carpet and upholstery cleaning services, as described in
5 NAICS industry code 56174.

6 (b) Business service center services, as described in NAICS
7 industry code 56143.

8 (c) Consulting services, as described in NAICS subsector code
9 5416, **EXCEPT FINANCIAL PLANNING AND BUDGETING, EQUITY AND ASSET**
10 **MANAGEMENT, OR OTHER FINANCIAL CONSULTING SERVICES.**

(d) Investigation, guard, and armored car services, as described in NAICS industry code 56161.

~~(e) Investment advice services, as described in NAICS industry code 52393.~~

(E) ~~(f)~~ Janitorial services, as described in NAICS industry code 56172.

(F) ~~(g)~~ Landscaping services, as described in NAICS industry code 56173.

14 exchange for the buyer's single payment, agrees to provide repair,
15 maintenance, or replacement of 1 or more items of tangible personal
16 property during a specific period of time, which services the buyer
17 is not required to buy in connection with the purchase of tangible
18 personal property.

20 industry code 56162.

21 (T) ~~(v)~~ Document preparation services, as described in NAICS
22 industry code 56141.

23 (U) ~~(w)~~ Miniwarehouse services and self-storage unit services,
24 as described in NAICS industry code 53113.

25 (2) A service is subject to tax under this section based on
26 the description of that service in the applicable NAICS code and
27 not the classification of the establishment providing that service.

1 (3) There is appropriated to the department of treasury for
2 the 2006-2007 state fiscal year the sum of \$100,000.00 to begin
3 implementing the requirements of the amendatory act that added this
4 section. Any portion of this amount under this section that is not
5 expended in the 2006-2007 state fiscal year shall not lapse to the
6 general fund but shall be carried forward in a work project account
7 that is in compliance with section 451a of the management and
8 budget act, 1984 PA 431, MCL 18.1451a, for the following state
9 fiscal year.

10 (4) The services set forth in subsection (1) shall be sourced
11 as products as provided in section 20.

12 (5) As used in this section, "NAICS" means North American
13 industry classification system, 2002 as produced by the United
14 States office of management and budget.
