A bill to provide for a waiting period and publication before the legislature may vote on certain appropriation- or revenuerelated bills.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the "72-
- 2 hour budget review act".
- 3 Sec. 3. As used in this act:
- 4 (a) "Amendment" means any proposed change in a bill.
 - (b) "Appropriation-related bill" means any bill authorizing an appropriation of funds for state operating, capital, or transportation expenses.
 - (c) "Publicly available" means that a bill or amendment has been posted on the legislature's website and published in a bill report, committee report, or conference report.
