- 1 SEC. 14J. (1) EFFECTIVE THE DATE OF THE AMENDATORY ACT THAT
- 2 ADDED THIS SECTION, ANY CONTRACT HELD BY THE DEPARTMENT OF HUMAN
- 3 SERVICES FOR SERVICES RELATING TO APPOINTED ATTORNEYS,
- 4 PSYCHOLOGISTS, PSYCHIATRISTS, OR COUNSELING FOR COURT-APPOINTED,
- 5 DEPARTMENT-APPOINTED, OR DEPARTMENT-DIRECTED SERVICES IS VOID AND
- 6 SHALL BE REPLACED USING A VOUCHER SYSTEM ESTABLISHED UNDER STATE
- 7 LAW.
- 8 (2) ANY PROVIDER OF A SERVICE COVERED UNDER THE VOUCHER SYSTEM

- 1 CERTIFIED, OR TRAINED MAY PLACE HIS OR HER NAME ON A COUNTY'S LIST
- 2 OF PROVIDERS COVERED UNDER THE COUNTY'S VOUCHER SYSTEM IN THE
- 3 COUNTY IN WHICH HE OR SHE PROVIDES THE SERVICES. HIS OR HER NAME
- 4 SHALL NOT BE REMOVED UNLESS THE DEPARTMENT RECEIVES NOTICE THAT THE
