

# HOUSE BILL No. 6713

November 19, 2008, Introduced by Reps. Robert Jones, Warren, Bauer, Alma Smith, Hopgood, Accavitti, Green, Byrum and Rick Jones and referred to the Committee on Senior Health, Security, and Retirement.

A bill to amend 1943 PA 240, entitled "State employees' retirement act," (MCL 38.1 to 38.69) by adding section 20i.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 20I. (1) BEGINNING JANUARY 1, 2009, THE MONTHLY  
2 RETIREMENT ALLOWANCE PAYABLE TO A RETIRANT OR RETIREMENT  
3 ALLOWANCE BENEFICIARY WHOSE RETIREMENT ALLOWANCE EFFECTIVE DATE  
4 WAS BEFORE OCTOBER 1, 1990 IS SUPPLEMENTED AS FOLLOWS:

12           (2) THE RECALCULATED RETIREMENT ALLOWANCE SHALL BE BASED  
13 UPON THE RETIREMENT ALLOWANCE THE RETIRANT OR THE RETIREMENT  
14 ALLOWANCE BENEFICIARY IS ENTITLED TO RECEIVE AS OF DECEMBER 31,  
15 2008 AND SHALL BE THE BASIS ON WHICH FUTURE ADJUSTMENTS TO THE  
16 ALLOWANCE ARE CALCULATED.
