February 6, 2007, Introduced by Senators VAN WOERKOM, PAPPAGEORGE, GILBERT, JANSEN, BIRKHOLZ, OLSHOVE, RICHARDVILLE, GARCIA, BROWN and ALLEN and referred to the Committee on Appropriations.

A bill to authorize a service bonus for certain veterans; and to make appropriations.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. When used in this act:
- (a) "Period of service" means that period of time between
 12:01 a.m., January 1, 1991 and the time when the United States
 Congress declares an end to hostilities in Iraq.
 - (b) "Veteran" means a person who completed at least 30 days of honorable service between January 1, 1991 and June 30, 1992 or 180 days of honorable service between June 30, 1992 and January 1, 2016 or died during the period of service from service-connected causes in the military, naval, marine, or coast guard forces of the United States including any auxiliary branches, was a resident of the state for at least 6 months before entering military service, and

- 1 has not applied for and received similar benefits from another
- 2 state. The required active duty does not include any of the
- 3 following:
- 4 (i) A period when assigned full-time by the armed forces to a
- 5 civilian institution for a course substantially the same as a
- 6 course offered to civilians.
- 7 (ii) A period served as a cadet or midshipman at a service
- 8 academy.
- 9 (iii) A period of active duty for training in an enlistment in
- 10 the army or air national guard or as a reserve for service in the
- 11 army, navy, air force, marine corps, or coast guard reserve.
- 12 (c) "Beneficiary" means, in relation to a deceased veteran,
- 13 the surviving husband or wife, child or children, or the dependent

- 17 (d) "Honorable service" means that service as evidenced by 1

- 2 (2) A veteran shall be paid a service bonus of \$500.00.
- 3 (3) A person shall not be entitled to a bonus as both a
- 4 veteran and a combat veteran.
- 5 (4) If the veteran or combat veteran is deceased, payment
- 6 shall be made to his or her beneficiary.
- 7 Sec. 3. The benefits provided in this act are not pay for
- 8 services rendered or subject to state or city income tax.
- 9 Sec. 4. The benefits provided herein expire when the United
- 10 States Congress declares an end to hostilities in Iraq.
- 11 Sec. 5. The legislature shall make appropriations fully
- 12 sufficient to pay the bonuses conferred in this act.
