## **SENATE BILL No. 549**

May 25, 2007, Introduced by Senators JELINEK, CROPSEY, GARCIA, KUIPERS and BISHOP and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code," (MCL 380.1 to 380.1852) by adding section 1284a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1284A. (1) NOT LATER THAN JULY 1, 2007, AN INTERMEDIATE
- 2 SCHOOL DISTRICT, IN COOPERATION WITH ITS CONSTITUENT DISTRICTS,
- 3 SHALL ADOPT A COMMON SCHOOL CALENDAR TO APPLY TO ALL OF ITS
- 4 CONSTITUENT DISTRICTS AND TO ITS INTERMEDIATE SCHOOL DISTRICT
- 5 PROGRAMS. THE COMMON SCHOOL CALENDAR SHALL MEET ALL OF THE
- 6 FOLLOWING:
  - (A) SHALL BE IN COMPLIANCE WITH SECTIONS 1284 AND 1284B.
- 8 (B) SHALL IDENTIFY THE DATES FOR EACH SCHOOL YEAR WHEN SCHOOL
- 9 WILL NOT BE IN SESSION FOR AT LEAST A WINTER BREAK, A SPRING BREAK,
- 0 AND PROFESSIONAL DEVELOPMENT DAYS. THE COMMON SCHOOL CALENDAR SHALL

- 1 IDENTIFY THESE DATES SPECIFICALLY FOR AT LEAST THE NEXT 10 SCHOOL
- 2 YEARS, BUT MAY DESCRIBE THESE DATES MORE GENERALLY FOR SCHOOL YEARS
- 3 THEREAFTER AS LONG AS THE DATES MAY BE READILY DETERMINED.
- 4 (2) BEGINNING WITH THE 2007-2008 SCHOOL YEAR, EXCEPT AS
- 5 OTHERWISE PROVIDED IN THIS SECTION, THE BOARD OF EACH CONSTITUENT
- 6 DISTRICT AND THE INTERMEDIATE SCHOOL BOARD SHALL ENSURE THAT ITS
- 7 SCHOOL CALENDAR COMPLIES WITH THE COMMON SCHOOL CALENDAR ADOPTED
- 8 UNDER SUBSECTION (1).
- 9 (3) IF A COLLECTIVE BARGAINING AGREEMENT THAT PROVIDES A
- 10 COMPLETE SCHOOL CALENDAR IS IN EFFECT FOR EMPLOYEES OF A SCHOOL
- 11 DISTRICT OR INTERMEDIATE SCHOOL DISTRICT AS OF THE EFFECTIVE DATE
- 12 OF THIS SECTION, AND IF THAT SCHOOL CALENDAR IS NOT IN COMPLIANCE
- 13 WITH THE COMMON SCHOOL CALENDAR ADOPTED UNDER SUBSECTION (1), THEN
- 14 SUBSECTION (2) DOES NOT APPLY TO THAT SCHOOL DISTRICT OR
- 15 INTERMEDIATE SCHOOL DISTRICT UNTIL AFTER THE EXPIRATION OF THAT
- 16 COLLECTIVE BARGAINING AGREEMENT.
