September 6, 2007, Introduced by Senators OLSHOVE, ALLEN, GARCIA, PAPPAGEORGE, RICHARDVILLE, BIRKHOLZ, HARDIMAN, KAHN, JELINEK, VAN WOERKOM, PATTERSON, CROPSEY, GILBERT, CASSIS, McMANUS, KUIPERS, JANSEN, SWITALSKI, STAMAS, BROWN, JACOBS, CHERRY, BARCIA, BISHOP, CLARKE, BASHAM, ANDERSON, SCHAUER, HUNTER and CLARK-COLEMAN and referred to the Committee on Senior Citizens and Veterans Affairs.

A bill to amend 1984 PA 431, entitled "The management and budget act," by amending section 141 (MCL 18.1141).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 141. The department shall do all of the following:

(a) Survey and examine the administrative organization and operations of state agencies to secure greater administrative and program efficiency and economy, to minimize the duplication of activities among state agencies and between state agencies and businesses, and to effect a better organization and consolidation of functions among state agencies. The findings of the surveys shall be incorporated and separately identified in the executive

- 4 (b) Provide for expert and uniform conduct in state operations
- 5 applicable to all state agencies.

- 9 (d) Establish a comprehensive system of internal controls in

- 16 STRATEGIC FUND AND MAKE AVAILABLE TO STATE AND FEDERAL AGENCIES AND
- 17 THE PUBLIC A CURRENT LIST OF BUSINESS ENTERPRISES DESIGNATED AS
- 18 MICHIGAN PATRIOT BUSINESSES UNDER THE MICHIGAN PATRIOT BUSINESS
- 19 ACT.
