

SENATE BILL No. 746

September 6, 2007, Introduced by Senators SCOTT, ALLEN, GARCIA, RICHARDVILLE, BIRKHOLZ, PAPPAGEORGE, HARDIMAN, JELINEK, VAN WOERKOM, PATTERSON, CROUSEY, GEORGE, GILBERT, CASSIS, McMANUS, KUIPERS, OLSHOVE, JANSEN, SWITALSKI, STAMAS, CHERRY, JACOBS, BROWN, BARCIA, GLEASON, WHITMER, BISHOP, BASHAM, ANDERSON, SCHAUER, HUNTER, CLARK-COLEMAN and CLARKE and referred to the Committee on Senior Citizens and Veterans Affairs.

A bill to amend 1998 PA 541, entitled
"Corrections officer's survivor tuition act,"
by amending section 4 (MCL 390.1264).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 4. (1) Beginning in the 1998-1999 academic year, upon
2 receiving an application under section 3(c), the department shall
3 determine whether the applicant and the courses for which tuition
4 waiver is sought meet the requirements of section 3 and, if so,
5 shall approve the application and notify the state institution of
6 higher education that the application has been approved.

7 (2) ~~Beginning~~ **SUBJECT TO SUBSECTION (3), BEGINNING** in the
8 1998-1999 academic year, upon application by the state institution

1 of higher education, the department annually shall reimburse each
2 state institution of higher education for the total amount of
3 tuition waived during the immediately preceding fiscal year under
4 section 3. The department annually shall report to the legislature
5 the number of individuals for whom tuition has been waived at each
6 state institution of higher education and the total amounts to be
7 paid under this act for that fiscal year.

8 (3) BEGINNING IN THE 2007-2008 ACADEMIC YEAR, THE DEPARTMENT
9 SHALL REIMBURSE UNDER SUBSECTION (2) ONLY THOSE STATE INSTITUTIONS
10 OF HIGHER EDUCATION THAT CONSIDER A STUDENT ENROLLED IN THAT
11 INSTITUTION A RESIDENT OF THIS STATE FOR DETERMINING HIS OR HER
12 TUITION RATES IF THE STUDENT IS AN ACTIVE DUTY MEMBER, OR THE
13 SPOUSE OR DEPENDENT CHILD OF AN ACTIVE DUTY MEMBER, OF THE ARMED
14 FORCES OF THE UNITED STATES, WHILE THAT ACTIVE DUTY MEMBER IS
15 STATIONED IN THIS STATE AND DURING THE STUDENT'S CONTINUOUS FULL-
16 TIME ENROLLMENT IN THE ACADEMIC DEGREE PROGRAM IN WHICH HE OR SHE
17 IS ENROLLED IF THAT ACTIVE DUTY MEMBER IS TRANSFERRED TO ACTIVE
18 DUTY OUTSIDE OF THIS STATE.
