

HOUSE SUBSTITUTE FOR
SENATE BILL NO. 597

A bill to amend 2008 PA 23, entitled
"Enhanced driver license and enhanced official state personal
identification card act,"
by amending section 6 (MCL 28.306).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6. (1) An application for an original enhanced driver
2 license or enhanced official state personal identification card
3 shall be accompanied by payment of a fee of not more than \$50.00.
4 (2) The renewal fee for an enhanced driver license or enhanced
5 official state personal identification card renewed under this act
6 shall be not more than \$50.00. However, if an enhanced driver
7 license or enhanced official state personal identification card is
8 expired at the time of renewal, the fee shall be the same as the
9 fee provided under subsection (1).
10 (3) Money from fees collected under subsections (1) and (2)

1 shall be deposited into the enhanced driver license and enhanced
2 official state personal identification card fund created in section
3 7 after distribution as follows:

4 (a) The secretary of state shall refund to each county or
5 municipality acting as an examining officer or examining bureau
6 \$2.50 for each applicant examined for an original enhanced driver
7 license, if the application is not denied and the money refunded is
8 paid to the county or local treasurer and is appropriated to the
9 county, municipality, or officer or bureau receiving the money for
10 the purpose of carrying out this act.

11 (b) The state treasurer shall deposit the sum of \$4.00 to the
12 traffic law enforcement and safety fund created in section 819a of
13 the Michigan vehicle code, 1949 PA 300, MCL 257.819a, for each
14 person examined for an original **OR RENEWAL** enhanced driver license.

15 (c) ~~Except as otherwise provided in subdivision (d), \$4.50~~
16 **FOUR DOLLARS AND 50 CENTS** of an original enhanced driver license
17 and \$6.00 of a renewal enhanced driver license shall be
18 appropriated to the transportation economic development fund
19 established in section 2 of 1987 PA 231, MCL 247.902, and shall not
20 be appropriated for any other purpose in any act making
21 appropriations of state funds.

22 ~~—(d) Notwithstanding subdivision (c), \$2,500,000.00 shall be~~
23 ~~deposited in the state treasury and credited to the general fund,~~
24 ~~except not more than \$1,000,000.00 shall be credited to the~~
25 ~~gasoline inspection and testing fund created under section 8 of the~~
26 ~~motor fuels quality act, 1984 PA 44, MCL 290.648.~~

27 (D) ~~(e)~~—The money remaining after distributions are made under

1 subdivisions (a) through ~~(d)~~-(C) shall remain in the enhanced
2 driver license and enhanced official state personal identification
3 card fund created under section 7.

4 (4) THE SECRETARY OF STATE MAY ASSESS A FEE FOR ISSUING A
5 DUPLICATE OR CORRECTED ENHANCED DRIVER LICENSE OR ENHANCED OFFICIAL
6 STATE PERSONAL IDENTIFICATION CARD. A FEE ASSESSED UNDER THIS
7 SUBSECTION SHALL NOT EXCEED THE FOLLOWING AMOUNTS:

8 (A) THIRTY DOLLARS FOR AN ENHANCED DRIVER LICENSE THAT IS AN
9 OPERATOR'S LICENSE.

10 (B) FORTY DOLLARS FOR AN ENHANCED DRIVER LICENSE THAT IS A
11 CHAUFFEUR'S LICENSE.

12 (C) THIRTY DOLLARS FOR AN ENHANCED OFFICIAL STATE PERSONAL
13 IDENTIFICATION CARD.

14 (5) A FEE SHALL NOT BE CHARGED UNDER SUBSECTION (4) FOR A
15 CHANGE OF ADDRESS, TO CORRECT A DEPARTMENTAL ERROR, OR TO ADD OR
16 REMOVE A HEART INSIGNIA DESCRIBED IN SECTION 310 OF THE MICHIGAN
17 VEHICLE CODE, 1949 PA 300, MCL 257.310.

18 (6) FEES COLLECTED UNDER SUBSECTION (4) SHALL BE DEPOSITED TO
19 THE ENHANCED DRIVER LICENSE AND ENHANCED OFFICIAL STATE PERSONAL
20 IDENTIFICATION CARD FUND CREATED UNDER SECTION 7.

21 (7) ~~(4)~~-A fee paid under this section is nonrefundable, except
22 for administrative error.
