- 7 of the billing by the end of the second fiscal quarter.
- 8 Sec. 205. (1) A hiring freeze is imposed on the state
- 9 classified civil service. State departments and agencies are
- 10 prohibited from hiring any new full-time state classified civil
- 11 service employees and prohibited from filling any vacant state
- 12 classified civil service positions. This hiring freeze does not

- 18 goods or services, or both, manufactured or provided by Michigan
- 19 businesses, if they are competitively priced and of comparable
- 20 quality. In addition, preference should be given to goods or
- 21 services, or both, that are manufactured or provided by Michigan
- 22 businesses owned and operated by veterans, if they are
- 23 competitively priced and of comparable quality.
- 24 Sec. 210. The director of each department receiving

- 20 Sec. 216. The department shall collect and computerize the
- 21 vehicle identification number (VIN) of all vehicles that are
- 22 entered into the state accident data collection system and make
- 23 this and other vehicle information available to the public at cost.
- 24 For bulk access to the accident records in which the VIN has been
- 25 collected and computerized, the department shall make those records
- 26 available to the public at cost, provided that the name and address
- 27 have been excluded.

- 1 Sec. 217. From the funds appropriated in part 1, the
- 2 department shall maintain a toll-free hotline in collaboration with
- 3 the department of education. The toll-free hotline shall be
- 4 operated 24 hours per day, 7 days per week, and shall provide
- 5 students, school officials, and other individuals an opportunity to
- 6 report specific threats of imminent school violence or other
- 7 suspicious or criminal conduct by juveniles to the appropriate
- 8 local law enforcement entities for investigation. The department
- 9 may expend funds for the promotion of the hotline.
- Sec. 218. (1) Funds appropriated in part 1 for at-post
- 11 troopers shall only be expended for trooper salaries, wages,
- 12 benefits, retirement, equipment, supplies, and other expenses
- 13 directly related to state troopers assigned to general law
- 14 enforcement duties at a department post, detachment, satellite
- 15 office, or a resident trooper function.
- 16 (2) It is the intent of the legislature that every effort be
- 17 made to identify funding sufficient to conduct a trooper school for
- 18 the purpose of working toward the goal of establishing a minimum
- 19 at-post trooper strength of 1,075 in this state.
- 20 (3) The department shall submit quarterly written reports to
- 21 the senate and house appropriations subcommittees on state police
- 22 and military and veterans affairs no later than December 1, 2010,
- 23 March 1, 2011, June 1, 2011, and September 1, 2011 which shall
- 24 include a trooper strength report and the status of the
- 25 department's plan for accomplishing the goal of subsection (2). If
- 26 the department determines that insufficient appropriations exist
- 27 under part 1 to accomplish the goal of subsection (2), the

- 1 department shall submit a proposal outlining a plan to accomplish
- 2 the goal, including an accounting of any additional funding
- 3 necessary to that end.
- 4 Sec. 219. The department of state police shall notify the
- 5 house and senate appropriations subcommittees on state police and
- 6 military and veterans affairs and the house and senate fiscal
- 7 agencies not less than 180 days before recommending to close or
- 8 consolidate any state police posts. The notification shall include
- 9 a local and state impact study of the proposed post closure or
- 10 consolidation.
- 11 Sec. 220. The department of state police, in keeping with its
- 12 role as the general law enforcement agency of the state and as the
- 13 law enforcement agency of last resort for communities that are
- 14 either without local law enforcement resources or are seriously
- 15 underserved by local law enforcement resources, shall provide
- 16 general law enforcement assistance to those communities until
- 17 adequate law enforcement services can be provided to those
- 18 communities by other means.
- 19 Sec. 221. The department of state police may pursue entering
- 20 into an agreement with Calhoun County to build a new facility in
- 21 Marshall which would serve as a new state police post to replace
- 22 the current state police post in Battle Creek.
- 23 Sec. 223. (1) Due to the current budgetary problems in this
- 24 state, out-of-state travel for the fiscal year ending September 30,
- 25 2011 shall be limited to situations in which 1 or more of the
- 26 following conditions apply:
- 27 (a) The travel is required by legal mandate or court order or

- 1 for law enforcement purposes.
- 2 (b) The travel is necessary to protect the health or safety of
- 3 Michigan citizens or visitors or to assist other states in similar
- 4 circumstances.
- 5 (c) The travel is necessary to produce budgetary savings or to
- 6 increase state revenues, including protecting existing federal
- 7 funds or securing additional federal funds.
- 8 (d) The travel is necessary to comply with federal
- 9 requirements.
- 10 (e) The travel is necessary to secure specialized training for
- 11 staff that is not available within this state.
- 12 (f) The travel is financed entirely by federal or nonstate
- 13 funds.
- 14 (2) If out-of-state travel is necessary but does not meet 1 or
- 15 more of the conditions in subsection (1), the state budget director
- 16 may grant an exception to allow the travel. Any exceptions granted
- 17 by the state budget director shall be reported on a monthly basis
- 18 to the senate and house of representatives standing committees on
- 19 appropriations.
- 20 (3) Not later than January 1, 2011, each department shall
- 21 prepare a travel report listing all travel by classified and
- 22 unclassified employees outside this state in the immediately
- 23 preceding fiscal year that was funded in whole or in part with
- 24 funds appropriated in the department's budget. The report shall be
- 25 submitted to the chairs and members of the senate and house of
- 26 representatives standing committees on appropriations, the fiscal
- 27 agencies, and the state budget director. The report shall include

- 1 the following information:
- 2 (a) The name of each person receiving reimbursement for travel
- 3 outside this state or whose travel costs were paid by this state.
- 4 (b) The destination of each travel occurrence.
- 5 (c) The dates of each travel occurrence.
- 6 (d) A brief statement of the reason for each travel
- 7 occurrence.
- 8 (e) The transportation and related costs of each travel
- 9 occurrence, including the proportion funded with state general
- 10 fund/general purpose revenues, the proportion funded with state
- 11 restricted revenues, the proportion funded with federal revenues,
- 12 and the proportion funded with other revenues.
- 13 (f) A total of all out-of-state travel funded for the
- 14 immediately preceding fiscal year.
- 15 Sec. 224. The department shall not take disciplinary action
- 16 against an employee for communicating with a member of the
- 17 legislature or his or her staff.
- 18 Sec. 226. The department of state police, in cooperation with
- 19 the department of technology, management, and budget, shall take
- 20 steps to encourage the development of state, local, and regional
- 21 tactical interoperable communication plans with the ultimate goal
- 22 being to ensure that effective and efficient communication
- 23 interoperability between radio communication systems of local,
- 24 regional, state, and federal agencies is established in every area
- 25 of the state. The department shall provide a written report to the
- 26 senate and house appropriations subcommittees on state police and
- 27 military and veterans affairs no later than April 1, 2011 on the

- 1 current status of reaching this objective. The report shall include
- 2 an accounting of exactly where within the state desired
- 3 interoperability has been achieved and what cooperative measures
- 4 and use of technology were used to achieve this interoperability,
- 5 and which areas of the state have not yet achieved such status. The
- 6 report shall also include a description of what strategies need to
- 7 be employed to ensure that the remaining areas of the state, and
- 8 the state as a whole, will have a communication system with
- 9 efficient and effective interoperability, particularly on occasions
- 10 when a multijurisdictional response to an emergency is warranted.
- 11 Sec. 232. The department shall place emphasis on recruiting
- 12 MCOLES certified police officers for the trooper recruit school.
- 13 Emphasis shall be given in the hiring process to those officers who
- 14 are on layoff and possess valid MCOLES certification. Any emphasis
- 15 given in the recruiting and selection process shall be consistent
- 16 with the department's hiring standards and in accordance with civil
- 17 service rules. The department shall report to the chairpersons of
- 18 the senate and house of representatives standing committees on
- 19 appropriations the results of its recruitment and selection
- 20 process, including the actual number of certified officers selected
- 21 for any recruit school that is held by September 30, 2011.
- Sec. 234. Funds appropriated in part 1 shall not be used by a
- 23 principal executive department, state agency, or authority to hire
- 24 a person to provide legal services that are the responsibility of
- 25 the attorney general. This prohibition does not apply to legal
- 26 services for bonding activities and for those activities that the
- 27 attorney general authorizes.

- 1 Sec. 235. (1) If a spending plan for the funds appropriated in
- 2 part 1 for special operations and events, or sources of financing
- 3 related to the spending plan, do not provide the level of program
- 4 service provided for in the current fiscal year, the funds
- 5 appropriated in part 1 for post uniform services or forensic
- 6 sciences shall not be used to fund the shortfall.
- 7 (2) If a spending plan for the funds appropriated in part 1
- 8 for special operations and events, or sources of financing related
- 9 to the spending plan, are in excess of that necessary to provide
- 10 the level of program service provided for in the current fiscal
- 11 year, the department shall take steps to transfer whatever excess
- 12 funding may exist to the funds appropriated in part 1 for post
- 13 uniform services and forensic sciences.
- 14 Sec. 238. The department of technology, management, and budget
- 15 shall work with the department of state police to reduce building
- 16 operations and leasing costs for all Michigan state police
- 17 facilities and to identify efficiencies and savings.
- 18 Sec. 239. It is the intent of the legislature that, should
- 19 funding become available, funds may be appropriated to the
- 20 department for traffic control purposes at the Michigan
- 21 international speedway.
- Sec. 240. (1) In addition to the funds appropriated in part 1,
- there is appropriated an amount not to exceed \$10,000,000.00 for
- 24 federal contingency funds. These funds are not available for
- 25 expenditure until they have been transferred to another line item
- 26 in this act under section 393(2) of the management and budget act,
- 27 1984 PA 431, MCL 18.1393.

- 1 (2) In addition to the funds appropriated in part 1, there is
- 2 appropriated an amount not to exceed \$3,500,000.00 for state
- 3 restricted contingency funds. These funds are not available for
- 4 expenditure until they have been transferred to another line item
- 5 in this act under section 393(2) of the management and budget act,
- 6 1984 PA 431, MCL 18.1393.
- 7 (3) In addition to the funds appropriated in part 1, there is
- 8 appropriated an amount not to exceed \$1,000,000.00 for local
- 9 contingency funds. These funds are not available for expenditure
- 10 until they have been transferred to another line item in this act
- 11 under section 393(2) of the management and budget act, 1984 PA 431,
- **12** MCL 18.1393.
- 13 (4) In addition to the funds appropriated in part 1, there is
- 14 appropriated an amount not to exceed \$200,000.00 for private
- 15 contingency funds. These funds are not available for expenditure
- 16 until they have been transferred to another line item in this act
- 17 under section 393(2) of the management and budget act, 1984 PA 431,
- **18** MCT₁ 18.1393.
- 19 Sec. 241. The department shall provide \$1,800,000.00 in Byrne
- 20 justice assistance grant program funding to the judiciary by
- 21 interdepartmental grant.
- Sec. 242. Not later than September 30, 2011, the department
- 23 shall prepare and transmit a report that provides for estimates of
- 24 the total general fund/general purpose appropriation lapses at the
- 25 close of the fiscal year. This report shall summarize the projected
- 26 year-end general fund/general purpose appropriation lapses by major
- 27 departmental program or program areas. The report shall be

- 1 transmitted to the office of the state budget, the chairpersons of
- 2 the senate and house appropriations committees, and the senate and
- 3 house fiscal agencies.
- 4 Sec. 245. The department shall work cooperatively with the
- 5 department of human services to coordinate the functions of the
- 6 state police LEIN system and the department of human services
- 7 bridges case management system to provide obtainable data that will
- 8 allow authorized users of the bridges case management system to
- 9 identify those persons who may be ineligible to receive certain
- 10 assistance services due to their law enforcement status. The
- 11 department shall deliver a report on this effort to the senate and
- 12 house appropriations subcommittees on state police and military and
- 13 veterans affairs not later than May 1, 2011.
- 14 Sec. 253. From the funds appropriated in part 1, the
- 15 department, working with MDMB, shall use an amount not to exceed
- 16 \$10,000.00 to develop and maintain a publicly accessible Internet
- 17 site to post all expenditures made by the department for the fiscal
- 18 year. The posting of expenditures shall include the purpose for
- 19 which each expenditure was made. The department is not required to
- 20 hire additional employees to comply with this section.
- Sec. 254. On a bimonthly basis, the department shall report on
- 22 the number of FTEs in pay status by civil service classification to
- 23 the house and senate appropriations subcommittees on state police
- 24 and military and veterans affairs and the house and senate fiscal
- 25 agencies.

26 INFORMATION TECHNOLOGY

- 1 Sec. 301. During fiscal year 2010-2011, an agency shall not be
- 2 billed a user fee to support the LEIN system except for those
- 3 agencies with an outstanding balance related to prior years' LEIN
- 4 user fees. Those agencies with an outstanding balance shall be
- 5 billed a LEIN user fee based upon the rate schedule established for
- 6 fiscal year 2009-2010.
- 7 Sec. 302. From the funds appropriated in part 1 for
- 8 information technology, departments and agencies shall pay user
- 9 fees to the department of technology, management, and budget for
- 10 technology-related services and projects. These user fees shall be
- 11 subject to provisions of an interagency agreement between the
- 12 department and the department of technology, management, and
- 13 budget.
- 14 Sec. 303. Amounts appropriated in part 1 for information
- 15 technology may be designated as work projects and carried forward
- 16 to support technology projects under the direction of the
- 17 department of technology, management, and budget. Funds designated
- 18 in this manner are not available for expenditure until approved as
- 19 work projects under section 451a of the management and budget act,
- 20 1984 PA 431, MCL 18.1451a.
- 21 Sec. 304. A portion of the funds appropriated in part 1 shall
- 22 be used by the department to produce a written report detailing
- 23 departmental policies regarding access to and use of information
- 24 from the LEIN system. The report shall include a description of
- 25 departmental measures to protect the security of information in the
- 26 LEIN system including safeguards that would prevent unauthorized
- 27 persons from obtaining information from the LEIN system. The

- 1 department shall submit a copy of this report to the senate and
- 2 house appropriations committees not later than April 1, 2011.
- 3 Sec. 305. The criminal justice information systems policy
- 4 council shall encourage members of the law enforcement agencies in
- 5 the state to be sensitive to, and note when necessary, activities
- 6 or circumstances that may suggest the unauthorized access or misuse
- 7 of information from the LEIN system. The criminal justice
- 8 information systems policy council shall advise LEIN auditors, as a
- 9 part of their audit of law enforcement agencies, to investigate in
- 10 depth all suspected incidents of improper access or improper use of
- 11 information from the LEIN system and determine whether or not those
- 12 incidents were illegal. In those incidents that may be determined
- 13 to be illegal, the executive secretary for the council shall
- 14 determine whether those incidents were of a negligent or criminal
- 15 nature. If an incident is determined to be an illegal act, the
- 16 council shall inform the chairs of both the senate and house
- 17 appropriations committees.
- 18 Sec. 306. (1) The department of state police, working with the
- 19 criminal justice information systems policy council, shall
- 20 implement procedures by which all probation information is placed
- 21 on the LEIN system. The LEIN system shall include information on
- 22 each probationer, including any probation conditions placed on a
- 23 probationer and the name of the probation officer assigned to a
- 24 probationer. The LEIN system shall also include any nonstandard
- 25 probation terms.
- 26 (2) If the department determines that amendments to the code
- 27 of criminal procedure, 1927 PA 175, MCL 760.1 to 777.69, are

- 1 required to include all probation information on the LEIN system,
- 2 the department shall deliver to members of the senate and house
- 3 appropriations subcommittees on state police and military affairs
- 4 amendments to the code of criminal procedure, 1927 PA 175, MCL
- 5 760.1 to 777.69, that, in the department's view, are necessary to
- 6 accomplish this goal. These proposed amendments shall be delivered
- 7 to subcommittee members not later than December 1, 2010.
- 8 Sec. 307. The department of state police shall serve as an
- 9 active liaison between the department of technology, management,
- 10 and budget and local public safety agencies to facilitate the use
- 11 of the Michigan public safety communications system towers by those
- 12 local public safety agencies that have an interest in using the
- 13 towers as a part of their own communications system. The department
- 14 of state police shall deliver a written report to the senate and
- 15 house appropriations subcommittees on state police and military and
- 16 veterans affairs by April 1, 2011, which shall include an
- 17 assessment of the progress toward establishing local public safety
- 18 agency use of the Michigan public safety communications system
- 19 towers, an accounting of problems that may be preventing local use
- 20 of the towers, and any recommendations the department has that may
- 21 foster this utilization.
- Sec. 308. The department of state police shall report any LEIN
- 23 fee increase to the senate and house appropriations subcommittees
- 24 on state police and military and veterans affairs 60 days prior to
- 25 the effective date of that increase. The report shall contain the
- 26 following information: the current fee structure and the total
- 27 revenue earned each year; the new fee structure and the total

- 1 revenue it is expected to earn annually; the total annual cost of
- 2 the LEIN system; and the total amount of LEIN fees paid by the
- 3 department under both the old and the new structure.
- 4 Sec. 309. From the funds appropriated in part 1 for
- 5 information technology, the department may develop and issue a
- 6 request for proposal for the development, implementation, and
- 7 maintenance of an electronic system for real-time enforcement of
- 8 section 3101 of the insurance code of 1956, 1956 PA 218, MCL
- **9** 500.3101.
- 10 Sec. 310. It is the intent of the legislature that the
- 11 Michigan public safety communications system (MPSCS) begin the
- 12 necessary expansion and upgrade of the system to allow for more
- 13 local users to utilize the system. The MPSCS shall use restricted
- 14 fund dollars, federal funds, and other non-general fund/general
- 15 purpose funds for this purpose.

16 HIGHWAY SAFETY PLANNING

- 17 Sec. 401. On a biannual basis, the department shall report to
- 18 the senate and house appropriations subcommittees on state police
- 19 and military and veterans affairs on the status of assessments
- 20 collected and authorized under section 629e of the Michigan vehicle
- 21 code, 1949 PA 300, MCL 257.629e, for the purposes of supporting the
- 22 secondary road patrol grant program. Each biannual report shall
- 23 contain updated information on collection levels, revised projected
- 24 grant allotments to counties for the year, a comparison of
- 25 projected collections and grant distribution levels with the funds
- 26 appropriated in part 1 for the secondary road patrol program, and

- 1 the extent collection levels have exceeded or failed to meet
- 2 appropriated levels for the current fiscal year or expenditure
- 3 levels from the previous fiscal year.

4 FORENSIC SCIENCES

- 5 Sec. 501. When changes are made to the department's protocol
- 6 for retaining and purging DNA analysis samples and records, the
- 7 department shall post a copy of the protocol changes on the
- 8 department's website.
- 9 Sec. 502. The department shall work with the department of
- 10 community health, the Michigan health and hospital association, the
- 11 Michigan state medical society, and the Michigan nurses association
- 12 to ensure that the recommendations included in the "Standard
- 13 Recommended Procedures for the Emergency Treatment of Sexual
- 14 Assault Victims" are followed in the collection of evidence.

MICHIGAN COMMISSION ON LAW ENFORCEMENT STANDARDS

- 16 Sec. 601. The money appropriated to the MCOLES for maintenance
- 17 and delivery of training to locals is provided in accordance with a
- 18 state reimbursement policy in which 100% of the determined state
- 19 reimbursement rate shall be distributed upon certification by the
- 20 MCOLES.

- 21 Sec. 603. The appropriation in part 1 for mental health
- 22 awareness training and coordination shall be expended for training
- 23 law enforcement officers, mental health practitioners, and other
- 24 criminal justice personnel in effective and safe ways of assisting
- 25 people with mental illness and directing people with mental

- 1 disorders to treatment programs.
- 2 Sec. 604. From the funds appropriated in part 1 to the
- 3 Michigan commission on law enforcement standards funds may be used
- 4 to provide training for motor carrier officers and capitol security
- 5 officers for the purpose of qualifying them for MCOLES
- 6 certification.

EMERGENCY MANAGEMENT

- 8 Sec. 801. (1) The state director of emergency management may
- 9 expend money appropriated under this act to call upon any agency or
- 10 department of the state or any resource of the state to protect
- 11 life or property or to provide for the health or safety of the
- 12 population in any area of the state in which the governor proclaims
- 13 a state of emergency or state of disaster under 1945 PA 302, MCL
- 14 10.31 to 10.33, or under the emergency management act, 1976 PA 390,
- 15 MCL 30.401 to 30.421. The state director of emergency management
- 16 may expend the amounts the director considers necessary to
- 17 accomplish these purposes. The director shall submit to the state
- 18 budget director as soon as possible a complete report of all
- 19 actions taken under the authority of this section. The report shall
- 20 contain, as a separate item, a statement of all money expended that
- 21 is not reimbursable from federal money. The state budget director
- 22 shall review the expenditures and submit recommendations to the
- 23 legislature in regard to any possible need for a supplemental
- 24 appropriation.
- 25 (2) In addition to the money appropriated in this act, the
- 26 department may receive and expend money from local, private,

- 1 federal, or state sources for the purpose of providing emergency
- 2 management training to local or private interests and for the
- 3 purpose of supporting emergency preparedness, response, recovery,
- 4 and mitigation activity. If additional expenditure authorization in
- 5 the Michigan administrative information network is approved by the
- 6 state budget office under this section, the department and the
- 7 state budget office shall notify the house and senate
- 8 appropriations subcommittees on state police and military and
- 9 veterans affairs and the house and senate fiscal agencies within 10
- 10 days after the approval. The notification shall include the amount
- 11 and source of the additional authorization, the date of its
- 12 approval, and the projected use of funds to be expended under the
- 13 authorization.
- 14 Sec. 803. The department's emergency management division shall
- 15 make every effort to ensure both of the following:
- 16 (a) That homeland security grants offered by the federal
- 17 government and channeled through the department are allocated to
- 18 first responder entities in the highest percentage possible.
- 19 (b) That homeland security grants awarded to the city of
- 20 Detroit shall not be used to supplant city general funds designated
- 21 to support first responder operations.

POST UNIFORM SERVICES

22

- 23 Sec. 901. State police enlisted personnel who are employed to
- 24 enforce traffic laws as provided in section 629e of the Michigan
- 25 vehicle code, 1949 PA 300, MCL 257.629e, shall not be prohibited
- 26 from responding to crimes in progress or other emergency

- 1 situations, and are responsible for protecting every citizen of
- 2 this state from harm.
- 3 Sec. 902. From the funds appropriated in part 1 for capitol
- 4 security quards, the department shall use these funds for security
- 5 services at the state capitol building. However, this shall not
- 6 preclude the capitol security guards from responding to emergencies
- 7 at the house office building, Farnum building, capitol parking lot,
- 8 and Roosevelt parking ramp.

9 STATEWIDE FIELD OPERATIONS

- 10 Sec. 1002. Money privately donated to the department is
- 11 appropriated under part 1 to be used for the purposes designated by
- 12 the donor of the money. Money privately donated to the department's
- 13 canine unit shall be used to purchase equipment and other items to
- 14 enhance the operation of the canine unit. It is the intent of the
- 15 legislature that money from private donations not supplant general
- 16 fund appropriations.

17 SPECIAL INVESTIGATIONS

- 18 Sec. 1101. (1) There is sufficient money appropriated in part
- 19 1 to special investigations to ensure that the citizens in a
- 20 service area of any state police post in the vicinity of a state
- 21 prison do not experience a downgrading of state police services in
- 22 their area. Special investigations shall be available by temporary
- 23 or permanent assignment of a detective when either a temporary or
- 24 permanent prison facility is opened.
- 25 (2) If the department is unable to comply with subsection (1)

- 1 and there is a prison scheduled to open, the department shall
- 2 provide troopers to serve as investigators on an interim basis.
- 3 Sec. 1102. From the funds appropriated in part 1 for special
- 4 investigations, the department shall provide a report to the
- 5 chairpersons of the senate and house of representatives standing
- 6 committees on appropriations no later than April 1, 2011 concerning
- 7 methamphetamine-related criminal activities.

MOTOR CARRIER ENFORCEMENT

- 9 Sec. 1201. (1) The department shall report to the house and
- 10 senate appropriations subcommittees on state police and the house
- 11 and senate fiscal agencies by March 1, 2011 regarding the
- 12 inspection of school buses and other motor vehicles under section
- 13 715a of the Michigan vehicle code, 1949 PA 300, MCL 257.715a, and
- 14 section 39 of the pupil transportation act, 1990 PA 187, MCL
- 15 257.1839. The report shall include the following information
- 16 regarding inspections conducted in calendar year 2010:
- 17 (a) The number of buses and vehicles inspected by the
- 18 department.

- 19 (b) The number of buses and vehicles passing and failing
- 20 inspection.
- 21 (c) The estimated number of buses and vehicles not inspected.
- 22 (2) If each school bus within a school system receives a 100%
- 23 successful state inspection on its first inspection in a given
- 24 year, the department shall award a certificate to that school
- 25 system.
