- 8 Sec. 215. Not later than January 1, 2011, the department shall
- 9 report to the state police appropriations subcommittees of the
- 10 house and senate and the house and senate fiscal agencies. The
- 11 report shall contain the following information regarding the
- 12 department's activities related to casino gaming oversight during
- 13 fiscal year 2009-2010:
- 14 (a) The amount of money received and expended.
- 15 (b) The nature and structure of the casino gaming oversight
- **16** unit.
- 17 (c) The positions and classifications of employees assigned.
- 18 (d) The number of full-time and part-time employees and the
- 19 aggregate number of FTEs.
- (e) The number of enlisted and civilian positions.
- 21 (f) The duties and responsibilities of the assigned employees.
- 22 (g) The immediate past position of the enlisted employees
- 23 assigned.
- 24 Sec. 216. The department shall collect and computerize the
- 25 vehicle identification number (VIN) of all vehicles that are
- 26 entered into the state accident data collection system and make
- 27 this and other vehicle information available to the public at cost.

- 1 For bulk access to the accident records in which the VIN has been

- 17 law enforcement agency of last resort for communities that are
- 18 either without local law enforcement resources or are seriously
- 19 underserved by local law enforcement resources, shall provide
- 20 general law enforcement assistance to those communities until
- 21 adequate law enforcement services can be provided to those
- 22 communities by other means.
- 23 Sec. 221. The department of state police may pursue entering
- 24 into an agreement with Calhoun County to build a new facility in
- 25 Marshall which would serve as a new state police post to replace
- 26 the current state police post in Battle Creek.
- Sec. 223. (1) Due to the current budgetary problems in this

- 1 state, out-of-state travel for the fiscal year ending September 30,
- 2 2011 shall be limited to situations in which 1 or more of the
- 3 following conditions apply:
- 4 (a) The travel is required by legal mandate or court order or
- 5 for law enforcement purposes.
- 6 (b) The travel is necessary to protect the health or safety of

- 19 Sec. 224. The department shall not take disciplinary action
- 20 against an employee for communicating with a member of the
- 21 legislature or his or her staff.
- Sec. 226. The department of state police, in cooperation with
- 23 the department of technology, management, and budget, shall take
- 24 steps to encourage the development of state, local, and regional
- 25 tactical interoperable communication plans with the ultimate goal
- 26 being to ensure that effective and efficient communication
- 27 interoperability between radio communication systems of local,

- 1 regional, state, and federal agencies is established in every area
- 2 of the state. The department shall provide a written report to the
- 3 senate and house appropriations subcommittees on state police and
- 4 military and veterans affairs no later than April 1, 2011 on the
- 5 current status of reaching this objective. The report shall include
- 6 an accounting of exactly where within the state desired
- 7 interoperability has been achieved and what cooperative measures

- 3 in this act under section 393(2) of the management and budget act,

- 5 (2) In addition to the funds appropriated in part 1, there is
- 6 appropriated an amount not to exceed \$3,500,000.00 for state
- 7 restricted contingency funds. These funds are not available for
- 8 expenditure until they have been transferred to another line item
- 9 in this act under section 393(2) of the management and budget act,

- 11 (3) In addition to the funds appropriated in part 1, there is
- appropriated an amount not to exceed \$1,000,000.00 for local

- 17 (4) In addition to the funds appropriated in part 1, there is

- 23 Sec. 241. The department shall provide \$1,800,000.00 in Byrne
- 24 justice assistance grant program funding to the judiciary by
- 25 interdepartmental grant.
- 26 Sec. 242. Not later than September 30, 2011, the department
- 27 shall prepare and transmit a report that provides for estimates of

- 1 the total general fund/general purpose appropriation lapses at the
- 2 close of the fiscal year. This report shall summarize the projected
- 3 year-end general fund/general purpose appropriation lapses by major
- 4 departmental program or program areas. The report shall be
- 5 transmitted to the office of the state budget, the chairpersons of
- 6 the senate and house appropriations committees, and the senate and
- 7 house fiscal agencies.
- 8 Sec. 243. The funds appropriated in part 1 have been reduced

- 24 Sec. 245. From the funds appropriated in part 1, the
- 25 department, working with the department of technology, management,
- 26 and budget and the department of human services, shall utilize no
- 27 more than \$60,000.00 to establish an automated connection between

- House Bill No. 5888 (H-3) as amended March 25, 2010 (1 of 2)
- 1 the state police LEIN system and the department of human services
- 2 bridges case management system to provide obtainable data that will
- 3 allow authorized users of the bridges case management system to

- 24 information systems policy council shall advise LEIN auditors, as a

- 26 depth all suspected incidents of improper access or improper use of
- 27 information from the LEIN system and determine whether or not those

- 1 incidents were illegal. In those incidents that may be determined

- 24 Sec. 307. The department of state police shall serve as an
- 25 active liaison between the department of technology, management,
- 26 and budget and local public safety agencies to facilitate the use
- 27 of the Michigan public safety communications system towers by those

- 1 local public safety agencies that have an interest in using the
- 2 towers as a part of their own communications system. The department
- 3 of state police shall deliver a written report to the senate and
- 4 house appropriations subcommittees on state police and military and
- 5 veterans affairs by April 1, 2011, which shall include an
- 6 assessment of the progress toward establishing local public safety
- 7 agency use of the Michigan public safety communications system
- 8 towers, an accounting of problems that may be preventing local use
- 9 of the towers, and any recommendations the department has that may
- 10 foster this utilization.
- 11 Sec. 308. The department of state police shall report any LEIN
- 12 fee increase to the senate and house appropriations subcommittees
- 13 on state police and military and veterans affairs 60 days prior to
- 14 the effective date of that increase. The report shall contain the
- 15 following information: the current fee structure and the total
- 16 revenue earned each year; the new fee structure and the total
- 17 revenue it is expected to earn annually; the total annual cost of
- 18 the LEIN system; and the total amount of LEIN fees paid by the
- 19 department under both the old and the new structure.
- 20 Sec. 309. From the funds appropriated in part 1 for
- 21 information technology, the department may develop and issue a
- 22 request for proposal for the development, implementation, and
- 23 maintenance of an electronic system for real-time enforcement of
- 24 section 3101 of the insurance code of 1956, 1956 PA 218, MCL
- **25** 500.3101.
- 26 Sec. 310. It is the intent of the legislature that the
- 27 Michigan public safety communications system (MPSCS) begin the

- 1 necessary expansion and upgrade of the system to allow for more
- 2 local users to utilize the system. The MPSCS shall use restricted
- 3 fund dollars, federal funds, and other non-general fund/general
- 4 purpose funds for this purpose.

5 HIGHWAY SAFETY PLANNING

- 6 Sec. 401. On a biannual basis, the department shall report to
- 7 the senate and house appropriations subcommittees on state police
- 8 and military and veterans affairs on the status of assessments
- 9 collected and authorized under section 629e of the Michigan vehicle
- 10 code, 1949 PA 300, MCL 257.629e, for the purposes of supporting the
- 11 secondary road patrol grant program. Each biannual report shall
- 12 contain updated information on collection levels, revised projected
- 13 grant allotments to counties for the year, a comparison of
- 14 projected collections and grant distribution levels with the funds
- 15 appropriated in part 1 for the secondary road patrol program, and
- 16 the extent collection levels have exceeded or failed to meet
- 17 appropriated levels for the current fiscal year or expenditure
- 18 levels from the previous fiscal year.

19 FORENSIC SCIENCES

- Sec. 501. When changes are made to the department's protocol
- 21 for retaining and purging DNA analysis samples and records, the
- 22 department shall post a copy of the protocol changes on the
- 23 department's website.
- 24 Sec. 502. The department shall work with the department of
- 25 community health, the Michigan health and hospital association, the

- 1 Michigan state medical society, and the Michigan nurses association
- 2 to ensure that the recommendations included in the "Standard
- 3 Recommended Procedures for the Emergency Treatment of Sexual
- 4 Assault Victims" are followed in the collection of evidence.

5 MICHIGAN COMMISSION ON LAW ENFORCEMENT STANDARDS

- 6 Sec. 601. The money appropriated to the MCOLES for maintenance
- 7 and delivery of training to locals is provided in accordance with a
- 8 state reimbursement policy in which 100% of the determined state
- 9 reimbursement rate shall be distributed upon certification by the
- 10 MCOLES.
- 11 Sec. 603. The appropriation in part 1 for mental health
- 12 awareness training and coordination shall be expended for training
- 13 law enforcement officers, mental health practitioners, and other
- 14 criminal justice personnel in effective and safe ways of assisting
- 15 people with mental illness and directing people with mental
- 16 disorders to treatment programs.
- 17 Sec. 604. From the funds appropriated in part 1 to the
- 18 Michigan commission on law enforcement standards funds may be used
- 19 to provide training for motor carrier officers and capitol security
- 20 officers for the purpose of qualifying them for MCOLES
- 21 certification.

22 EMERGENCY MANAGEMENT

- Sec. 801. (1) The state director of emergency management may
- 24 expend money appropriated under this act to call upon any agency or
- 25 department of the state or any resource of the state to protect

- 1 life or property or to provide for the health or safety of the
- 2 population in any area of the state in which the governor proclaims
- 3 a state of emergency or state of disaster under 1945 PA 302, MCL
- 4 10.31 to 10.33, or under the emergency management act, 1976 PA 390,
- 5 MCL 30.401 to 30.421. The state director of emergency management
- 6 may expend the amounts the director considers necessary to
- 7 accomplish these purposes. The director shall submit to the state
- 8 budget director as soon as possible a complete report of all
- 9 actions taken under the authority of this section. The report shall
- 10 contain, as a separate item, a statement of all money expended that
- 11 is not reimbursable from federal money. The state budget director
- 12 shall review the expenditures and submit recommendations to the
- 13 legislature in regard to any possible need for a supplemental
- 14 appropriation.
- 15 (2) In addition to the money appropriated in this act, the
- 16 department may receive and expend money from local, private,
- 17 federal, or state sources for the purpose of providing emergency
- 18 management training to local or private interests and for the
- 19 purpose of supporting emergency preparedness, response, recovery,
- 20 and mitigation activity. If additional expenditure authorization in
- 21 the Michigan administrative information network is approved by the
- 22 state budget office under this section, the department and the
- 23 state budget office shall notify the house and senate
- 24 appropriations subcommittees on state police and military and
- 25 veterans affairs and the house and senate fiscal agencies within 10
- 26 days after the approval. The notification shall include the amount
- 27 and source of the additional authorization, the date of its

- 1 approval, and the projected use of funds to be expended under the
- 2 authorization.
- 3 Sec. 803. The department's emergency management division shall
- 4 make every effort to ensure both of the following:
- 5 (a) That homeland security grants offered by the federal
- 6 government and channeled through the department are allocated to
- 7 first responder entities in the highest percentage possible.
- 8 (b) That homeland security grants awarded to the city of
- 9 Detroit shall not be used to supplant city general funds designated
- 10 to support first responder operations.

11 POST UNIFORM SERVICES

- Sec. 901. State police enlisted personnel who are employed to
- 13 enforce traffic laws as provided in section 629e of the Michigan
- 14 vehicle code, 1949 PA 300, MCL 257.629e, shall not be prohibited
- 15 from responding to crimes in progress or other emergency
- 16 situations, and are responsible for protecting every citizen of
- 17 this state from harm.
- 18 Sec. 902. From the funds appropriated in part 1 for capitol
- 19 security guards, the department shall use these funds for security
- 20 services at the state capitol building, house office building,
- 21 Farnum building, capitol parking lot, and Roosevelt parking ramp.

22 STATEWIDE FIELD OPERATIONS

- Sec. 1002. Money privately donated to the department is
- 24 appropriated under part 1 to be used for the purposes designated by
- 25 the donor of the money. Money privately donated to the department's

- 1 canine unit shall be used to purchase equipment and other items to
- 2 enhance the operation of the canine unit. It is the intent of the
- 3 legislature that money from private donations not supplant general
- 4 fund appropriations.

5 SPECIAL INVESTIGATIONS

- 6 Sec. 1101. (1) There is sufficient money appropriated in part
- 7 1 to special investigations to ensure that the citizens in a
- 8 service area of any state police post in the vicinity of a state
- 9 prison do not experience a downgrading of state police services in
- 10 their area. Special investigations shall be available by temporary
- 11 or permanent assignment of a detective when either a temporary or
- 12 permanent prison facility is opened.
- 13 (2) If the department is unable to comply with subsection (1)
- 14 and there is a prison scheduled to open, the department shall
- 15 provide troopers to serve as investigators on an interim basis.
- Sec. 1102. From the funds appropriated in part 1 for special
- 17 investigations, the department shall provide a report to the

- 23 senate appropriations subcommittees on state police and the house
- 24 and senate fiscal agencies by March 1, 2011 regarding the

- 4 regarding inspections conducted in calendar year 2010:
- 5 (a) The number of buses and vehicles inspected by the

- 9 (c) The estimated number of buses and vehicles not inspected.
- 10 (2) If each school bus within a school system receives a 100%
- 11 successful state inspection on its first inspection in a given
