8 **GENERAL SECTIONS**

9 Sec. 201. In accordance with the provisions of section 30 of

10 article IX of the state constitution of 1963, total state spending

13 paid to local units of government are \$0.

17 **INFORMATION TECHNOLOGY**

18 Sec. 301. The funds appropriated in part 1 shall be used

19 solely for the acquisition and deployment of a state integrated IP-

20 based 9-1-1 mapping system.
