SUBSTITUTE FOR HOUSE BILL NO. 6183

A bill to amend 1976 PA 388, entitled "Michigan campaign finance act,"

(MCL 169.201 to 169.282) by adding section 55a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 55A. (1) A CORPORATION OR JOINT STOCK COMPANY THAT MAKES
- 2 AN INDEPENDENT EXPENDITURE SHALL SUBMIT A REPORT TO THE SECRETARY
- 3 OF STATE AT LEAST 5 DAYS BEFORE THE DATE OF THE INDEPENDENT
- 4 EXPENDITURE. THE REPORT SHALL BE SUBMITTED ELECTRONICALLY OVER THE
- 5 INTERNET IN THE MANNER PRESCRIBED BY THE SECRETARY OF STATE AND
- 6 SHALL BE IMMEDIATELY POSTED ON THE SECRETARY OF STATE'S WEBSITE.
- 7 THE REPORT SHALL INCLUDE THE DATES OF THE EXPENDITURE, THE
- 8 CANDIDATE TO WHOM THE COMMUNICATION FUNDED BY THE EXPENDITURE
- 9 REFERS, THE AMOUNT OF THE EXPENDITURE, THE NAME AND ADDRESS OF THE

- 1 PERSON TO WHOM THE EXPENDITURE WILL BE PAID, THE NAME AND ADDRESS
- 2 OF THE PERSON FILING THE REPORT, AND THE NAMES AND ADDRESSES OF ALL
- 3 CONTRIBUTORS TO THE EXPENDITURE.
- 4 (2) A CORPORATION OR JOINT STOCK COMPANY THAT MAKES AN
- 5 INDEPENDENT EXPENDITURE SHALL PLACE 1 OF THE FOLLOWING DISCLAIMERS
- 6 ON THE COMMUNICATION:
- 7 (A) PRINTED COMMUNICATION DISCLAIMERS SHALL STATE: "PAID FOR
- 8 WITH CORPORATE OR JOINT STOCK COMPANY FUNDS BY
- 9 (NAME AND ADDRESS OF CORPORATION OR JOINT STOCK COMPANY) " AND
- 10 INCLUDE THE NAME AND PHOTOGRAPH OF THE PRESIDENT OF THAT
- 11 CORPORATION OR JOINT STOCK COMPANY. THE DISCLAIMER MUST BE OF
- 12 SUFFICIENT TYPE SIZE TO BE CLEARLY READABLE, MUST BE CONTAINED IN A
- 13 PRINTED BOX SET APART FROM THE OTHER CONTENT OF THE COMMUNICATION,
- 14 AND MUST BE LEGIBLE.
- 15 (B) ELECTRONIC COMMUNICATION DISCLAIMERS SHALL COMPLY WITH
- 16 SUBDIVISION (A) AND SHALL BE CLEARLY READABLE DURING THE ENTIRE
- 17 BROADCAST OF THE ADVERTISEMENT. ELECTRONIC COMMUNICATION INCLUDES
- 18 ANY ELECTRONIC MEANS OF VISUAL COMMUNICATION, SUCH AS TELEVISION
- 19 AND THE INTERNET.
- 20 (C) RADIO COMMUNICATION DISCLAIMERS SHALL INCLUDE THE VOICE OF
- 21 THE PRESIDENT OF THE CORPORATION OR JOINT STOCK COMPANY MAKING THE
- 22 STATEMENT IN SUBDIVISION (A) AND IDENTIFYING HIMSELF OR HERSELF AS
- 23 THE PRESIDENT OF THE CORPORATION OR JOINT STOCK COMPANY.
