A bill to make appropriations for the department of state police and certain other state purposes for the fiscal year ending September 30, 2010; to provide for the expenditure of those appropriations; to provide for certain reports and the consideration of those reports; to provide for the disposition of other income received by the various state agencies; to provide for certain emergency powers; and to provide for the powers and duties of certain committees, certain state agencies, and certain employees.

- 3 (d) "DNA" means deoxyribonucleic acid.
- 4 (e) "DOJ" means the United States department of justice.
- 5 (f) "DOT" means the United States department of
- 6 transportation.
- 7 (q) "FEMA" means the federal emergency management agency.
- 8 (h) "FTE" means full-time equated.
- 9 (i) "IDG" means interdepartmental grant.
- 10 (j) "IDT" means intradepartmental transfer.
- 11 (k) "LEIN" means law enforcement information network.
- 12 (l) "MCOLES" means the Michigan commission on law enforcement
- 13 standards.
- 14 (m) "MDCH" means the Michigan department of community health.
- (n) "MDMB" means the Michigan department of management and
- 16 budget.
- 17 (o) "MDOC" means the Michigan department of corrections.
- (p) "MDOS" means the Michigan department of state.
- 19 (q) "MDOT" means the Michigan department of transportation.
- (r) "MDTR" means the Michigan department of treasury.
- 21 (s) "MPSCS" means the Michigan public safety communications
- 22 system.
- 23 Sec. 204. The department of civil service shall bill
- 24 departments and agencies at the end of the first fiscal quarter for
- 25 the 1% charge authorized by section 5 of article XI of the state
- 26 constitution of 1963. Payments shall be made for the total amount
- 27 of the billing by the end of the second fiscal quarter.

- 1 Sec. 205. (1) A hiring freeze is imposed on the state
- 2 classified civil service. State departments and agencies are
- 3 prohibited from hiring any new full-time state classified civil
- 4 service employees and prohibited from filling any vacant state
- 5 classified civil service positions. This hiring freeze does not
- 6 apply to internal transfers of classified employees from 1 position

- 7 to another within a department.
- 8 (2) The state budget director may grant exceptions to this
- 9 hiring freeze when the state budget director believes that the
- 10 hiring freeze will result in rendering a state department or agency
- 11 unable to deliver basic services, causes loss of revenue to the
- 12 state, would result in the inability of the state to receive
- 13 federal funds, or would necessitate additional expenditures that
- 14 exceed any savings from maintaining a vacancy. The state budget
- 15 director shall report quarterly to the chairpersons of the senate
- 16 and house of representatives standing committees on appropriations
- 17 the number of exceptions to the hiring freeze approved during the
- 18 previous quarter and the reasons to justify the exception.
- 19 Sec. 207. At least 60 days before beginning any effort to
- 20 privatize, the department shall submit a complete project plan to
- 21 the appropriate senate and house of representatives appropriations
- 22 subcommittees and the senate and house fiscal agencies. The plan
- 23 shall include the criteria under which the privatization initiative
- 24 will be evaluated. The evaluation shall be completed and submitted
- 25 to the appropriate senate and house of representatives
- 26 appropriations subcommittees and the senate and house fiscal
- 27 agencies within 30 months.

1 Sec. 208. Unless otherwise specified, the department shall use

- 2 the Internet to fulfill the reporting requirements of this act.
- 3 This requirement may include transmission of reports via electronic
- 4 mail to the recipients identified for each reporting requirement or
- 5 it may include placement of reports on an Internet or Intranet
- 6 site.
- 7 Sec. 209. Funds appropriated in part 1 shall not be used for
- 8 the purchase of foreign goods or services, or both, if
- 9 competitively priced and of comparable quality American goods or
- 10 services, or both, are available. Preference shall be given to
- 11 goods or services, or both, manufactured or provided by Michigan
- 12 businesses, if they are competitively priced and of comparable
- 13 quality. In addition, preference should be given to goods or
- 14 services, or both, that are manufactured or provided by Michigan
- 15 businesses owned and operated by veterans, if they are
- 16 competitively priced and of comparable quality.
- 17 Sec. 210. The director of each department receiving
- 18 appropriations in part 1 shall take all reasonable steps to ensure
- 19 businesses in deprived and depressed communities compete for and
- 20 perform contracts to provide services or supplies, or both, for the
- 21 department. The director shall strongly encourage firms with which
- 22 the department contracts to subcontract with certified businesses
- 23 in depressed and deprived communities for services or supplies, or
- 24 both.
- Sec. 211. It is the intent of the legislature that personnel
- 26 of the department who request and are eligible for reimbursement of
- 27 expenses related to the operation of the department be reimbursed

- 1 from the appropriations provided in this act within 30 days after
- 2 submitting a request, or the eligible personnel shall be paid an
- 3 additional amount equal to 0.75% of the payment due. The department
- 4 shall pay an additional amount equal to 0.75% of the payment due
- 5 for the first month and each succeeding month or portion of a month
- 6 the payment remains past due.
- 7 Sec. 213. (1) It is the intent of the legislature that the
- 8 department shall not provide any subsidy for contractual services
- 9 it provides.
- 10 (2) When the department provides contractual services to a
- 11 local unit of government, the department shall be reimbursed for
- 12 all costs incurred in providing the services, including, but not
- 13 limited to, retirement and overtime costs.
- 14 (3) Contractual services provided to an entity other than a
- 15 local unit of government may be provided by department personnel,
- 16 but only on an overtime basis outside the normal work schedule of
- 17 the personnel.
- 18 (4) This section does not apply to state agencies.
- 19 Sec. 214. The departments and agencies receiving
- 20 appropriations in part 1 shall receive and retain copies of all
- 21 reports funded from appropriations in part 1. The department shall
- 22 follow all federal quidelines and state laws regarding short-term
- 23 and long-term retention of records.
- Sec. 215. Not later than January 1, 2010, the department shall
- 25 report to the state police appropriations subcommittees of the
- 26 house and senate and the house and senate fiscal agencies. The
- 27 report shall contain the following information regarding the

- 1 department's activities related to casino gaming oversight during
- 2 fiscal year 2008-2009:
- 3 (a) The amount of money received and expended.
- 4 (b) The nature and structure of the casino gaming oversight
- 5 unit.
- 6 (c) The positions and classifications of employees assigned.
- 7 (d) The number of full-time and part-time employees and the
- 8 aggregate number of FTEs.
- 9 (e) The number of enlisted and civilian positions.
- 10 (f) The duties and responsibilities of the assigned employees.
- 11 (g) The immediate past position of the enlisted employees
- 12 assigned.
- 13 Sec. 216. The department shall collect and computerize the
- 14 vehicle identification number (VIN) of all vehicles that are
- 15 entered into the state accident data collection system and make
- 16 this and other vehicle information available to the public at cost.
- 17 For bulk access to the accident records in which the VIN has been
- 18 collected and computerized, the department shall make those records
- 19 available to the public at cost, provided that the name and address
- 20 have been excluded.
- Sec. 217. From the funds appropriated in part 1, the
- 22 department shall maintain a toll-free hotline in collaboration with
- 23 the department of education. The toll-free hotline shall be
- 24 operated 24 hours per day, 7 days per week, and shall provide
- 25 students, school officials, and other individuals an opportunity to
- 26 report specific threats of imminent school violence or other
- 27 suspicious or criminal conduct by juveniles to the appropriate

- 1 local law enforcement entities for investigation. The department
- 2 may expend funds for the promotion of the hotline.
- 3 Sec. 218. (1) Funds appropriated in part 1 for at-post
- 4 troopers shall only be expended for trooper salaries, wages,
- 5 benefits, retirement, equipment, supplies, and other expenses
- 6 directly related to state troopers assigned to general law
- 7 enforcement duties at a department post, detachment, satellite
- 8 office, or a resident trooper function.
- 9 (2) It is the intent of the legislature that every effort be
- 10 made to identify funding sufficient to conduct a trooper school for
- 11 the purpose of working toward the goal of establishing a minimum
- 12 at-post trooper strength of 1,075 in this state.
- 13 (3) The department shall submit quarterly written reports to
- 14 the senate and house appropriations subcommittees on state police
- 15 and military and veterans affairs no later than December 1, 2009,
- 16 March 1, 2010, June 1, 2010, and September 1, 2010 which shall
- 17 include a trooper strength report and the status of the
- 18 department's plan for accomplishing the goal of subsection (2). If
- 19 the department determines that insufficient appropriations exist
- 20 under part 1 to accomplish the goal of subsection (2), the
- 21 department shall submit a proposal outlining a plan to accomplish
- 22 the goal, including an accounting of any additional funding
- 23 necessary to that end.
- 24 Sec. 219. The department of state police shall notify the
- 25 house and senate appropriations subcommittees on state police and
- 26 military and veterans affairs and the house and senate fiscal
- 27 agencies not less than 180 days before recommending to close or

- 1 consolidate any state police posts. The notification shall include
- 2 a local and state impact study of the proposed post closure or
- 3 consolidation.
- 4 Sec. 220. The department of state police, in keeping with its
- 5 role as the general law enforcement agency of the state and as the
- 6 law enforcement agency of last resort for communities that are
- 7 either without local law enforcement resources or are seriously
- 8 underserved by local law enforcement resources, shall provide
- 9 general law enforcement assistance to those communities until
- 10 adequate law enforcement services can be provided to those
- 11 communities by other means.
- 12 Sec. 221. The department of state police may pursue entering
- 13 into an agreement with Calhoun County to build a new facility in
- 14 Marshall which would serve as a new state police post to replace
- 15 the current state police post in Battle Creek.
- 16 Sec. 223. (1) Due to the current budgetary problems in this
- 17 state, out-of-state travel for the fiscal year ending September 30,
- 18 2010 shall be limited to situations in which 1 or more of the
- 19 following conditions apply:
- 20 (a) The travel is required by legal mandate or court order or
- 21 for law enforcement purposes.
- (b) The travel is necessary to protect the health or safety of
- 23 Michigan citizens or visitors or to assist other states in similar
- 24 circumstances.

- 7 (2) If out-of-state travel is necessary but does not meet 1 or
- 8 more of the conditions in subsection (1), the state budget director
- 9 may grant an exception to allow the travel. Any exceptions granted
- 10 by the state budget director shall be reported on a monthly basis
- 11 to the senate and house of representatives standing committees on
- 12 appropriations.
- 13 (3) Not later than January 1, 2010, each department shall
- 14 prepare a travel report listing all travel by classified and
- 15 unclassified employees outside this state in the immediately
- 16 preceding fiscal year that was funded in whole or in part with
- 17 funds appropriated in the department's budget. The report shall be
- 18 submitted to the chairs and members of the senate and house of

- 4 restricted revenues, the proportion funded with federal revenues,
- 5 and the proportion funded with other revenues.
- 6 (f) A total of all out-of-state travel funded for the
- 7 immediately preceding fiscal year.
- 8 Sec. 224. The department shall not take disciplinary action
- 9 against an employee for communicating with a member of the
- 10 legislature or his or her staff.
- 11 Sec. 225. It is the intent of the legislature that the
- 12 administration, working with the MCOLES, continue the long-held
- 13 practice that all revenue made available to the department from the
- 14 Michigan justice training fund be used solely for costs directly
- 15 related to the delivery of Michigan justice training fund grants,
- 16 so that in the future, eligible entities as provided under 1982 PA
- 17 302, MCL 18.421 to 18.429, will have a stable and accurate source
- 18 of training funds.
- 19 Sec. 226. The department of state police, in cooperation with
- 20 the department of information technology and others, shall take

- 12 Sec. 232. The department shall place emphasis on recruiting
- 13 MCOLES certified police officers for the trooper recruit school.
- 14 Emphasis shall be given in the hiring process to those officers who
- 15 are on layoff and possess valid MCOLES certification. Any emphasis
- 16 given in the recruiting and selection process shall be consistent
- 17 with the department's hiring standards and in accordance with civil
- 18 service rules. The department shall report to the chairpersons of
- 19 the senate and house of representatives standing committees on
- 20 appropriations the results of its recruitment and selection
- 21 process, including the actual number of certified officers selected

- 23 Sec. 234. Funds appropriated in part 1 shall not be used by a

- 2 Sec. 235. (1) If a spending plan for the funds appropriated in
- 3 part 1 for special operations and events, or sources of financing
- 4 related to the spending plan, do not provide the level of program
- 5 service provided for in the current fiscal year, the funds
- 6 appropriated in part 1 for post uniform services or forensic
- 7 sciences shall not be used to fund the shortfall.
- 8 (2) If a spending plan for the funds appropriated in part 1

- 15 Sec. 237. From the funds appropriated in part 1, the

- 20 Sec. 238. The department of management and budget shall work
- 21 with the department of state police to reduce building operations
- 22 and leasing costs for all Michigan state police facilities and to
- 23 identify efficiencies and savings.
- 24 Sec. 239. It is the intent of the legislature that, should
- 25 funding become available, funds may be appropriated to the
- 26 department for traffic control purposes at the Michigan
- 27 international speedway.

- 1 Sec. 240. (1) In addition to the funds appropriated in part 1,
- 2 there is appropriated an amount not to exceed \$10,000,000.00 for
- 3 federal contingency funds. These funds are not available for
- 4 expenditure until they have been transferred to another line item
- 5 in this act under section 393(2) of the management and budget act,
- 6 1984 PA 431, MCL 18.1393.
- 7 (2) In addition to the funds appropriated in part 1, there is
- 8 appropriated an amount not to exceed \$3,500,000.00 for state
- 9 restricted contingency funds. These funds are not available for
- 10 expenditure until they have been transferred to another line item
- 11 in this act under section 393(2) of the management and budget act,
- 12 1984 PA 431, MCL 18.1393.
- 13 (3) In addition to the funds appropriated in part 1, there is
- 14 appropriated an amount not to exceed \$1,000,000.00 for local
- 15 contingency funds. These funds are not available for expenditure
- 16 until they have been transferred to another line item in this act
- 17 under section 393(2) of the management and budget act, 1984 PA 431,

- 19 (4) In addition to the funds appropriated in part 1, there is
- 20 appropriated an amount not to exceed \$200,000.00 for private
- 21 contingency funds. These funds are not available for expenditure
- 22 until they have been transferred to another line item in this act
- 23 under section 393(2) of the management and budget act, 1984 PA 431,
- **24** MCL 18.1393.
- 25 Sec. 251. The funding in part 1 for at-post trooper
- 26 restoration from federal ARRA assistance to rural law enforcement
- 27 grant funding shall be contingent upon the receipt of federal funds

- 1 associated with the American recovery and reinvestment act of 2009
- 2 assistance to rural law enforcement grant program.
- 3 Sec. 252. The line-item appropriations in part 1 financed by
- 4 federal funds designated as ARRA funding represent federal funds
- 5 associated with the American recovery and reinvestment act of 2009,
- 6 Public Law 111-5. These federal funds are temporary in nature. It
- 7 is the intent of the legislature that when these temporary federal
- 8 funds are fully expended, the program funding levels supported by
- 9 these temporary federal funds will not be continued.
- 10 Sec. 253. From the funds appropriated in part 1, the
- 11 department shall use an amount not to exceed \$10,000.00 to develop
- 12 and maintain a publicly accessible Internet site to post all

26 INFORMATION TECHNOLOGY

- 1 Sec. 301. The money appropriated in part 1 for computer
- 2 services shall be funded by LEIN user fees sufficient to pay 33% of
- 3 the state's service and contract maintenance costs of the LEIN.
- 4 Sec. 302. From the funds appropriated in part 1 for
- 5 information technology, departments and agencies shall pay user
- 6 fees to the department of information technology for technology-
- 7 related services and projects. These user fees shall be subject to
- 8 provisions of an interagency agreement between the department and
- 9 the department of information technology.
- 10 Sec. 303. Amounts appropriated in part 1 for information
- 11 technology may be designated as work projects and carried forward
- 12 to support technology projects under the direction of the
- 13 department of information technology. Funds designated in this
- 14 manner are not available for expenditure until approved as work
- 15 projects under section 451a of the management and budget act, 1984

- 17 Sec. 304. A portion of the funds appropriated in part 1 shall
- 18 be used by the department to produce a written report detailing
- 19 departmental policies regarding access to and use of information
- 20 from the LEIN system. The report shall include a description of
- 21 departmental measures to protect the security of information in the
- 22 LEIN system including safeguards that would prevent unauthorized
- 23 persons from obtaining information from the LEIN system. The
- 24 department shall submit a copy of this report to the senate and
- 25 house appropriations committees not later than April 1, 2010.
- 26 Sec. 305. The criminal justice information systems policy
- 27 council shall encourage members of the law enforcement agencies in

- 1 the state to be sensitive to, and note when necessary, activities
- 2 or circumstances that may suggest the unauthorized access or misuse

- 3 of information from the LEIN system. The criminal justice
- 4 information systems policy council shall advise LEIN auditors, as a
- 5 part of their audit of law enforcement agencies, to investigate in
- 6 depth all suspected incidents of improper access or improper use of
- 7 information from the LEIN system and determine whether or not those
- 8 incidents were illegal. In those incidents that may be determined
- 9 to be illegal, the executive secretary for the council shall

- 19 probationer and the name of the probation officer assigned to a

- 22 (2) If the department determines that amendments to the code
- 23 of criminal procedure, 1927 PA 175, MCL 760.1 to 777.69, are
- 24 required to include all probation information on the LEIN system,
- 25 the department shall deliver to members of the senate and house
- 26 appropriations subcommittees on state police and military affairs
- 27 amendments to the code of criminal procedure, 1927 PA 175, MCL

- 1 760.1 to 777.69, that, in the department's view, are necessary to
- 2 accomplish this goal. These proposed amendments shall be delivered
- 3 to subcommittee members not later than December 1, 2009.
- 4 Sec. 307. The department of state police shall serve as an
- 5 active liaison between the department of information technology and
- 6 local public safety agencies to facilitate the use of the Michigan
- 7 public safety communications system towers by those local public
- 8 safety agencies that have an interest in using the towers as a part
- 9 of their own communications system. The department of state police
- 10 shall deliver a written report to the senate and house
- 11 appropriations subcommittees on state police and military and
- 12 veterans affairs by April 1, 2010, which shall include an
- 13 assessment of the progress toward establishing local public safety
- 14 agency use of the Michigan public safety communications system
- 15 towers, an accounting of problems that may be preventing local use
- 16 of the towers, and any recommendations the department has that may
- 17 foster this utilization.
- 18 Sec. 308. The department of state police shall report any LEIN
- 19 fee increase to the senate and house appropriations subcommittees
- 20 on state police and military and veterans affairs 60 days prior to
- 21 the effective date of that increase. The report shall contain the
- 22 following information: the current fee structure and the total
- 23 revenue earned each year; the new fee structure and the total
- 24 revenue it is expected to earn annually; the total annual cost of
- 25 the LEIN system; and the total amount of LEIN fees paid by the
- 26 department under both the old and the new structure.
- Sec. 309. From the funds appropriated in part 1 for

- 1 information technology, the department may develop and issue a
- 2 request for proposal for the development, implementation, and
- 3 maintenance of an electronic system for real-time enforcement of
- 4 section 3101 of the insurance code of 1956, 1956 PA 218, MCL
- **5** 500.3101.

HIGHWAY SAFETY PLANNING

- 7 Sec. 401. On a biannual basis, the department shall report to
- 8 the senate and house appropriations subcommittees on state police
- 9 and military affairs on the status of assessments collected and
- 10 authorized under section 629e of the Michigan vehicle code, 1949 PA
- 11 300, MCL 257.629e, for the purposes of supporting the secondary
- 12 road patrol grant program. Each biannual report shall contain
- 13 updated information on collection levels, revised projected grant
- 14 allotments to counties for the year, a comparison of projected
- 15 collections and grant distribution levels with the funds
- 16 appropriated in part 1 for the secondary road patrol program, and
- 17 the extent collection levels have exceeded or failed to meet
- 18 appropriated levels for the current fiscal year or expenditure
- 19 levels from the previous fiscal year.

FORENSIC SCIENCES

- 21 Sec. 501. (1) The department shall distribute a copy of the
- 22 department's protocol for retaining and purging DNA analysis
- 23 samples and records to each police agency in this state.
- 24 (2) The department shall report to the house and senate
- 25 appropriations subcommittees on state police and military and

- 1 veterans affairs and the house and senate fiscal agencies when any
- 2 changes to the department's DNA protocol are made.
- 3 Sec. 502. The department shall work with the department of
- 4 community health, the Michigan health and hospital association, the
- 5 Michigan state medical society, and the Michigan nurses association
- 6 to ensure that the recommendations included in the "Standard
- 7 Recommended Procedures for the Emergency Treatment of Sexual
- 8 Assault Victims" are followed in the collection of evidence.

9 MICHIGAN COMMISSION ON LAW ENFORCEMENT STANDARDS

- 10 Sec. 601. The money appropriated to the MCOLES for maintenance
- 11 and delivery of training to locals is provided in accordance with a
- 12 state reimbursement policy in which 100% of the determined state
- 13 reimbursement rate shall be distributed upon certification by the
- 14 MCOLES.
- 15 Sec. 603. The appropriation in part 1 for mental health
- 16 awareness training and coordination shall be expended for training
- 17 law enforcement officers, mental health practitioners, and other
- 18 criminal justice personnel in effective and safe ways of assisting
- 19 people with mental illness and directing people with mental

EMERGENCY MANAGEMENT

- 4 Sec. 801. (1) The state director of emergency management may
- 5 expend money appropriated under this act to call upon any agency or
- 6 department of the state or any resource of the state to protect
- 7 life or property or to provide for the health or safety of the
- 8 population in any area of the state in which the governor proclaims
- 9 a state of emergency or state of disaster under 1945 PA 302, MCL
- 10 10.31 to 10.33, or under the emergency management act, 1976 PA 390,
- 11 MCL 30.401 to 30.421. The state director of emergency management
- 12 may expend the amounts the director considers necessary to
- 13 accomplish these purposes. The director shall submit to the state

- 16 contain, as a separate item, a statement of all money expended that
- 17 is not reimbursable from federal money. The state budget director
- 18 shall review the expenditures and submit recommendations to the

- 21 (2) In addition to the money appropriated in this act, the
- 22 department may receive and expend money from local, private,
- 23 federal, or state sources for the purpose of providing emergency
- 24 management training to local or private interests and for the
- 25 purpose of supporting emergency preparedness, response, recovery,
- 26 and mitigation activity. If additional expenditure authorization in

- 1 the Michigan administrative information network is approved by the
- 2 state budget office under this section, the department and the
- 3 state budget office shall notify the house and senate
- 4 appropriations subcommittees on state police and military and
- 5 veterans affairs and the house and senate fiscal agencies within 10
- 6 days after the approval. The notification shall include the amount

18 POST UNIFORM SERVICES

- 19 Sec. 901. State police enlisted personnel who are employed to

- 21 vehicle code, 1949 PA 300, MCL 257.629e, shall not be prohibited
- 22 from responding to crimes in progress or other emergency
- 23 situations, and are responsible for protecting every citizen of
- 24 this state from harm.
- 25 Sec. 902. From the funds appropriated in part 1 for security
- 26 guards, the department shall only use these funds for security

1 services at the state capitol building.

STATEWIDE FIELD OPERATIONS

- 3 Sec. 1002. Money privately donated to the department is
- 4 appropriated under part 1 to be used for the purposes designated by
- 5 the donor of the money. Money privately donated to the department's
- 6 canine unit shall be used to purchase equipment and other items to
- 7 enhance the operation of the canine unit.

8 SPECIAL INVESTIGATIONS

- 9 Sec. 1101. (1) There is sufficient money appropriated in part
- 10 1 to special investigations to ensure that the citizens in a
- 11 service area of any state police post in the vicinity of a state
- 12 prison do not experience a downgrading of state police services in
- 13 their area. Special investigations shall be available by temporary
- 14 or permanent assignment of a detective when either a temporary or
- 15 permanent prison facility is opened.
- 16 (2) If the department is unable to comply with subsection (1)
- 17 and there is a prison scheduled to open, the department shall
- 18 provide troopers to serve as investigators on an interim basis.

19 MOTOR CARRIER ENFORCEMENT

- 20 Sec. 1201. (1) The department shall report to the house and
- 21 senate appropriations subcommittees on state police and the house
- 22 and senate fiscal agencies by March 1, 2010 regarding the
- 23 inspection of school buses and other motor vehicles under section
- 24 715a of the Michigan vehicle code, 1949 PA 300, MCL 257.715a, and

- 1 section 39 of the pupil transportation act, 1990 PA 187, MCL
- 2 257.1839. The report shall include the following information
- 3 regarding inspections conducted in calendar year 2009:
- 4 (a) The number of buses and vehicles inspected by the
- 5 department.
- 6 (b) The number of buses and vehicles passing and failing
- 7 inspection.
- 8 (c) The estimated number of buses and vehicles not inspected.
- 9 (2) If each school bus within a school system receives a 100%
- 10 successful state inspection on its first inspection in a given
- 11 year, the department shall award a certificate to that school
- 12 system.
