18 PROVISIONS CONCERNING APPROPRIATIONS

19 GENERAL SECTIONS

Sec. 201. In accordance with the provisions of section 30 of article IX of the state constitution of 1963, total state spending from state resources in this appropriation act for the fiscal year ending September 30, 2010 is \$2,000,000.00 and state appropriations paid to local units of government are \$0.

Sec. 202. The appropriations made and expenditures authorized

- 1 under this act and the departments, commissions, boards, offices,
- 2 and programs for which appropriations are made under this act are
- 3 subject to the management and budget act, 1984 PA 431, MCL 18.1101
- 4 to 18.1594.
- 5 Sec. 203. The line-item appropriations in part 1 financed by
- 6 federal funds designated as ARRA funding represent federal funds
- 7 associated with the American recovery and reinvestment act of 2009,
- 8 Public Law 111-5. These federal funds are temporary in nature. It
- 9 is the intent of the legislature that when these temporary federal
- 10 funds are fully expended, the program funding levels and any state
- 11 employees supported by these temporary federal funds will not be
- 12 continued.
- Sec. 210. (1) In addition to the funds appropriated in part 1,
- 14 there is appropriated an amount equal to any additional federal
- 15 funding awarded to this state through recalculation of formulas and
- 16 under the redistribution provisions of the American recovery and
- 17 reinvestment act of 2009, Public Law 111-5.
- 18 (2) Within 30 days of receiving such an award, a department
- 19 shall report to the senate and house appropriations subcommittees,
- 20 senate and house fiscal agencies, state budget director, and the
- 21 governor on the amount of funds received and the purposes for which
- 22 they will be spent.
- Sec. 211. The unexpended funds appropriated in part 1 and in
- 24 section 210 and any unencumbered or unallotted funds are carried
- 25 forward into the succeeding fiscal year. The following is in
- 26 compliance with section 451a(1) of the management and budget act,
- 27 1984 PA 431, MCL 18.1451a:

- 1 (a) The purposes of the projects to be carried forward are to
- 2 protect and invest in the natural resources, infrastructure, and
- 3 people of the state of Michigan in accordance with the provisions
- 4 of the American recovery and reinvestment act of 2009, Public Law
- **5** 111-5.
- 6 (b) The projects will be accomplished by state employees and
- 7 by contract.
- 8 (c) The total estimated cost of all projects is identified in
- 9 each line-item appropriation.
- 10 (d) The tentative completion date is September 30, 2012.
- 11 Sec. 212. (1) In a form and manner determined by the recipient
- 12 department, local governments and other eligible sub-recipients
- 13 receiving funds through this act shall comply will all requirements
- 14 corresponding to the receipt of funds, including, but not limited
- 15 to, any certifications, assurances, and accountability and
- 16 transparency provisions required in the American recovery and
- 17 reinvestment act of 2009, Public Law 111-5.
- 18 (2) Funds appropriated in part 1 may be transferred to sub-
- 19 recipient state departments or agencies in an interdepartmental
- 20 grant consistent with the requirements of the American recovery and
- 21 reinvestment act of 2009, Public Law 111-5.

22 DEPARTMENT OF HUMAN SERVICES

- 23 Sec. 301. From the funds appropriated in part 1 for
- 24 demonstration projects, the department of human services shall
- 25 allocate \$2,000,000.00 to Self-Help Addiction Rehabilitation, Inc.
- 26 for community services and outreach activities. These amounts may

- 1 be designated as a work project and carried forward to support the
- 2 demonstration projects under the direction of the department of
- 3 human services. The funds described in this section are not
- 4 available for expenditure in a subsequent fiscal year until

[DEPARTMENT OF TRANSPORTATION

Sec. 401. The department shall report by March 1 of each year to the house and senate appropriations subcommittees on transportation and the house and senate fiscal agencies on the uses of funds appropriated in part 1 from the American recovery and reinvestment act of 2009, Public Law 111-5. The report shall include a description of funds expended by expenditure object, including expenditure detail of sub-recipients, for the preceding fiscal year. The report shall also indicate the balance of funds appropriated but not yet expended as of the end of the preceding fiscal year.]
