THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 621. (1) (a) The driver OPERATOR of any vehicle involved

- 3 legally upon or adjacent to a highway shall take reasonable steps
- 4 to locate and notify the owner or person in charge of such THAT
- 5 property of such THE accident and of SHALL PROVIDE his OR HER name

- 7 is driving and shall upon OR WAS OPERATING AT THE TIME OF THE
