SUBSTITUTE FOR SENATE BILL NO. 950

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 286.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 286. (1) A PERSON SHALL NOT MISREPRESENT HIS OR HER
- 2 CURRENT OR FORMER MILITARY STATUS WHEN HE OR SHE MAKES ANY OF THE
- 3 FOLLOWING CLAIMS, ORALLY OR IN WRITING OR BY FALSE DISPLAY, WITH
- 4 THE INTENT TO DEFRAUD, OBTAIN EMPLOYMENT, OR BE ELECTED OR
- 5 APPOINTED TO PUBLIC OFFICE:
- 6 (A) THAT HE OR SHE IS ENTITLED TO WEAR MILITARY AWARDS,
- 7 MILITARY DECORATIONS, OR MILITARY RANK.
- 8 (B) THAT HE OR SHE SERVED IN THE UNITED STATES ARMED FORCES, A

- 1 RESERVE COMPONENT OF THE UNITED STATES ARMED FORCES, OR THE
- 2 NATIONAL GUARD.
- 3 (C) THAT HE OR SHE SERVED IN THE MILITARY DURING A WARTIME
- 4 ERA, WHETHER OR NOT THERE WAS A DECLARED WAR, OR SERVED IN A COMBAT
- 5 ZONE.
- 6 (D) THAT HE OR SHE SERVED, OR IS SERVING, IN THE MILITARY AT A
- 7 CERTAIN LOCATION, WITH A CERTAIN RANK OR RATING, OR ENGAGED IN A
- 8 CERTAIN MISSION, OR ANY OTHER CLAIM CONCERNING HIS OR HER ACTUAL
- 9 MILITARY SERVICE.
- 10 (2) THIS SECTION DOES NOT APPLY TO A PERSON WHO OR AN
- 11 ORGANIZATION THAT DOES 1 OR MORE OF THE FOLLOWING:
- 12 (A) REENACTS MILITARY HISTORY OR A MILITARY EVENT.
- 13 (B) PLAYS THE PART OF A MEMBER OF THE UNITED STATES ARMED
- 14 FORCES, A RESERVE COMPONENT OF THE UNITED STATES ARMED FORCES, OR
- 15 THE NATIONAL GUARD IN A PLAY, MOTION PICTURE, TELEVISION
- 16 PRODUCTION, OR OTHER DRAMATIC PRODUCTION, OR AT A PATRIOTIC OR
- 17 CIVIC EVENT.
- 18 (C) SERVES AS A MEMBER OF THE UNITED STATES ARMED FORCES, A
- 19 RESERVE COMPONENT OF THE UNITED STATES ARMED FORCES, OR THE
- 20 NATIONAL GUARD AND, AS PART OF A MILITARY ASSIGNMENT, IS
- 21 REPRESENTING A MEMBER OF THE UNITED STATES ARMED FORCES IN A
- 22 PREVIOUS WAR OR TIME PERIOD FOR CEREMONIAL, RECRUITING, OR TRAINING
- 23 PURPOSES.
- 24 (D) WORKS AS AN EMPLOYEE OF OR VOLUNTEER FOR A MUSEUM AND, AS
- 25 A PART OF HIS OR HER DUTIES, IS REPRESENTING A MEMBER OF THE UNITED
- 26 STATES ARMED FORCES, A RESERVE COMPONENT OF THE UNITED STATES ARMED
- 27 FORCES, OR THE NATIONAL GUARD FOR CEREMONIAL, HISTORICAL, OR

- 1 TRAINING PURPOSES.
- 2 (E) OWNS, DISPLAYS, PURCHASES, SELLS, OR TRADES MILITARIA,
- 3 INCLUDING, BUT NOT LIMITED TO, MEDALS, RIBBONS, AND RANK INSIGNIA,
- 4 AND DOES NOT CLAIM TO HAVE PERSONALLY EARNED THEM UNLESS HE OR SHE
- 5 IS LEGALLY ENTITLED TO DO SO.
- 6 (F) USES HIS OR HER GIVEN NAME THAT INCLUDES A MILITARY RANK,
- 7 SO LONG AS HE OR SHE DOES NOT USE THE NAME TO DEFRAUD ANOTHER IN A
- 8 MANNER PROHIBITED BY THIS SECTION.
- 9 (G) USES A NAME OR HONORARY MILITARY OR MILITARY-LIKE RANK
- 10 THAT HAS BEEN BESTOWED UPON HIM OR HER BY A PUBLIC OFFICER, PUBLIC
- 11 EMPLOYEE, OR PUBLIC AGENCY, IN THE NAME OF A PUBLIC OFFICER OR
- 12 PUBLIC AGENCY.
- 13 (H) USES A CORPORATE, PARTNERSHIP, SOLE PROPRIETORSHIP, OR
- 14 OTHER NAME FOR A BUSINESS OR PRODUCT THAT INCLUDES A MILITARY RANK,
- 15 SO LONG AS THE NAME IS NOT USED TO DEFRAUD ANOTHER IN A MANNER
- 16 PROHIBITED BY THIS SECTION.
- 17 (I) HOLDS A REGISTERED TRADEMARK THAT INCLUDES A MILITARY RANK
- 18 OR HONORARY RANK, SO LONG AS THE TRADEMARK IS NOT USED TO DEFRAUD
- 19 ANOTHER IN A MANNER PROHIBITED BY THIS SECTION.
- 20 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
- 21 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1 YEAR, A
- 22 FINE OF NOT MORE THAN \$5,000.00, OR BOTH, AND NOT MORE THAN 100
- 23 HOURS OF COMMUNITY SERVICE, THAT SHALL BE PERFORMED IN A VETERANS
- 24 HOME OR FOR A VETERANS SERVICE ORGANIZATION.
- 25 (4) A PERSON MAY BE CHARGED WITH, CONVICTED OF, AND SENTENCED
- 26 FOR ANY OTHER VIOLATION OF LAW IN ADDITION TO THE VIOLATION OF THIS
- 27 SECTION.

- 1 (5) THIS SECTION SHALL BE KNOWN AND MAY BE CITED AS THE
- 2 "STOLEN VALOR LAW".
