## **HOUSE BILL No. 4545**

March 10, 2009, Introduced by Rep. Smith and referred to the Committee on Commerce.

A bill to amend 1963 PA 62, entitled "Industrial development revenue bond act of 1963," by amending section 3 (MCL 125.1253).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3. (1) A municipality may:
- 2 (a) Construct, acquire by gift or purchase, reconstruct,
- 3 improve, maintain or repair industrial buildings within or without
- 4 the municipality, acquire sites for those activities, and enlarge
- 5 or remodel industrial buildings.
- 6 (b) Acquire by gift or purchase industrial machinery and
- 7 equipment, but only in conjunction with a project whereby the
- 8 municipality will construct, acquire by gift or purchase,
- 9 reconstruct, improve, or remodel the industrial building in or near

- 1 which the industrial machinery or equipment will be located.
- 2 (c) Issue revenue bonds to finance the costs of the
- 3 acquisition, purchase, construction, reconstruction, or remodeling
- 4 of industrial buildings, the acquisition and improvement of sites,
- 5 the acquisition of industrial machinery and equipment, and the
- 6 refunding of bonds issued pursuant to this act.
- 7 (d) Enter into lease or lease purchase agreements with any
- 8 person, firm or corporation for the use of the industrial building,
- 9 the site therefor and industrial machinery and equipment. The
- 10 agreement shall provide that the rents to be charged for the use
- 11 shall be fixed and revised from time to time so as to produce
- 12 income and revenues sufficient to pay promptly when due the
- 13 interest upon and the principal of all bonds issued payable
- 14 therefrom after provision has been made for the payment of
- 15 operation and maintenance costs. Whenever such agreement shall
- 16 relate to industrial machinery or equipment, it shall specify that
- 17 the machinery or equipment shall remain in or near the industrial
- 18 building until provision has been made for the retirement in full
- 19 of all bonds issued therefor unless the industrial machinery and
- 20 equipment is replaced without cost to the municipality with similar
- 21 machinery and equipment of equivalent value and utility.
- (e) Mortgage the industrial building, the site, and any
- 23 industrial machinery and equipment in favor of the holders of the
- 24 bonds issued therefor.
- 25 (f) Sell and convey the industrial building, the site, and any
- 26 industrial machinery and equipment, including without limitation
- 27 the sale and conveyance thereof subject to a mortgage, for a price

- 1 and at a time which THAT the governing body may determine, but a
- 2 sale or conveyance shall not be made in a manner that would impair
- 3 the rights or interests of the holders of bonds issued payable from
- 4 the rentals of the building, site, machinery or equipment.
- 5 (2) BEGINNING JANUARY 1, 2010, A MUNICIPALITY SHALL NOT ENTER
- 6 INTO AN AGREEMENT WITH A BUSINESS UNDER THIS ACT THAT HAS FAILED TO
- 7 COMPLY WITH SECTION 3 OF THE MICHIGAN CORPORATE RESPONSIBILITY ACT
- 8 OR THAT HAS FAILED TO DISCLOSE A CIVIL OR CRIMINAL OFFENSE AS
- 9 REQUIRED BY SECTION 3 OF THE MICHIGAN CORPORATE RESPONSIBILITY ACT.
