May 12, 2009, Introduced by Reps. Mayes, Moore, Stamas and Ball and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled

"Public health code,"

(MCL 333.1101 to 333.25211) by adding section 17776.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 17776. (1) A PHARMACY OR CHARITABLE CLINIC THAT MEETS THE
- 2 ELIGIBILITY REQUIREMENTS FOR PARTICIPATION IN THE PALMS ESTABLISHED
- 3 BY SECTION 17775 AND ANY RULES PROMULGATED UNDER SECTION 17777 MAY
- 4 DO ANY OF THE FOLLOWING:
- 5 (A) DISPENSE PRESCRIPTION DRUGS DONATED UNDER THE PALMS TO
- 6 ELIGIBLE PARTICIPANTS.
 - (B) IF ESTABLISHED BY RULE UNDER SECTION 17777, CHARGE
- 8 ELIGIBLE PARTICIPANTS WHO RECEIVE DONATED UNUSED PRESCRIPTION DRUGS
 - A HANDLING FEE FOR THE SERVICE.
 - (2) A PHARMACY OR CHARITABLE CLINIC THAT MEETS THE ELIGIBILITY

- 11 (5) FOR PURPOSES OF THE LAWFUL DONATION, ACCEPTANCE, OR
- 12 DISPENSING OF A PRESCRIPTION DRUG MANUFACTURED BY THE MANUFACTURER
- 13 THAT IS DONATED BY ANY ENTITY UNDER THE PALMS, A MANUFACTURER IS
- 14 NOT, IN THE ABSENCE OF BAD FAITH OR GROSS NEGLIGENCE, SUBJECT TO
- 15 CRIMINAL OR CIVIL LIABILITY FOR INJURY OTHER THAN FOR DEATH, OR
- 16 LOSS TO PERSON OR PROPERTY, INCLUDING, BUT NOT LIMITED TO,
- 17 LIABILITY FOR FAILURE TO TRANSFER OR COMMUNICATE PRODUCT OR
