## **HOUSE BILL No. 4912**

May 12, 2009, Introduced by Rep. Smith and referred to the Committee on Labor.

A bill to amend 1943 PA 240, entitled

"State employees' retirement act,"

by amending section 45 (MCL 38.45), as amended by 2002 PA 743.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 45. As used in sections 45 to 47:
- 2 (a) "Covered position" means any of the following:
- $\mathbf{3}$  (i) On or after January 1, 1989, a position in the classified
- 4 civil service with a classification of corrections officer;
- 5 resident unit officer; corrections medical aide; corrections shift
- 6 supervisor; corrections security specialist; deputy prison warden;
  - or departmental administrator-prison warden.
- (ii) On or after January 1, 1989, a position that is assigned
- 9 to a work station inside the security perimeter of a state

- 1 correctional facility designated as "medium", "close", or
- 2 "maximum".
- 3 (iii) On or after January 1, 1989, a position within a state
- 4 correctional facility that requires the employee to be in direct
- 5 contact with prisoners for more than 50% of the employee's work
- 6 time performing supervisory or disciplinary duties including 1 or
- 7 more of the following:
- 8 (A) Supervising prisoners in the performance of tasks.
- 9 (B) Supervising prisoners for the purpose of enforcing the
- 10 facility's rules.
- 11 (C) Direct participation in the disciplinary process.
- (iv) On or after January 1, 1989, a position with the center
- 13 for forensic psychiatry that is classified by civil service as
- 14 forensics security aide IIB, forensics security aide IIIB,
- 15 forensics security supervisor IVB, forensics security supervisor
- 16 VB, forensics security supervisor VIB, or forensics supervisor VII,
- 17 AND ON AND AFTER JANUARY 1, 2009, A POSITION WITH THE CENTER FOR
- 18 FORENSIC PSYCHIATRY THAT IS CLASSIFIED BY CIVIL SERVICE AS
- 19 REGISTERED NURSE MANAGER 13.
- (v) A position that was a covered position under this section
- 21 before January 1, 1989, that is excluded by subparagraphs (i), (ii),
- 22 (iii), and (iv), if and only as long as the person in the position on
- 23 January 1, 1989, continues in the position after January 1, 1989.
- 24 (b) "Supplemental member" means a member who is employed in a
- 25 covered position.
- 26 (c) "Covered service" means credited service acquired in a
- 27 covered position.

- 1 (d) "Supplemental final average compensation" means 1/3 of the
- 2 compensation paid a supplemental member during the period of 3
- 3 consecutive years of the member's covered service producing the
- 4 highest average and contained within the member's last 10 years of
- 5 credited service immediately preceding the date the member's
- 6 employment in a covered position last terminates.
- 7 (e) "State correctional facility" means a facility under the
- 8 jurisdiction of the department of corrections that has a
- 9 designation of "maximum", "close", "medium", "minimum", "prison
- 10 camp", or "correction center".
