- 15 purchase upon performance of the conditions stated in the agreement
- 16 and with an immediate right of possession vested in the conditional
- vendee or lessee.
- 18 (iii) A person renting a snowmobile or having the exclusive use
- 19 of a snowmobile for more than 30 days.
- 20 (1) "Peace officer" means any of the following:
- (i) A sheriff.
- 22 (ii) A sheriff's deputy.
- 23 (iii) A deputy who is authorized by a sheriff to enforce this
- 24 part and who has satisfactorily completed at least 40 hours of law
- 25 enforcement training, including training specific to this part.

- 12 ALCOHOLIC liquor or a controlled substance, or both. , or who
- 13 (B) THE PERSON has a blood AN alcohol content of 0.10-0.08

- 15 breath, or per 67 milliliters of urine.
- 16 (C) THE PERSON'S ABILITY TO OPERATE A SNOWMOBILE IS VISIBLY

- 19 (2) A peace officer who has reasonable cause to believe that a
- 20 person was operating a snowmobile and that, by the consumption of
- 21 intoxicating ALCOHOLIC liquor, the person may have affected his or
- 22 her ability to operate a snowmobile may require the person to

The results of the test shall be offered as 6 evidence by the prosecution in that trial. Failure to fully comply 7 with the request bars the admission of the results into evidence by 8 9 the prosecution. Sec. 82140. - 10 snowmobile.
- (ii) If the court finds that the person has 1 or more prior
- 12 convictions within 7 years for a violation of section 82127(1),
- 13 (4), or (5), former section 15a(1), (4), or (5) of Act No. 74 of
- 14 the Public Acts of 1968 1968 PA 74, or former section 15a, a local
- 15 ordinance substantially corresponding to section 82127(1) or former
- 16 section 15a, or a law of another state substantially corresponding
- 17 to section 82127(1), (4), or (5) or former section 15a, or that the
- 18 person has 2 or more prior convictions within 10 ANY PERIOD OF
- 19 years for a violation of section 82127(1), (3), (4), or (5), former
- 20 section 15a(1), (3), (4), or (5) of Act No. 74 of the Public Acts
- 21 of 1968 PA 74, or former section 15a, or another snowmobile
- 22 substance abuse offense, the court shall order, without an
- 23 expiration date, that the person not operate a snowmobile.
- 24 (c) For a conviction under section 82127(3) or a local
- 25 ordinance substantially corresponding to section 82127(3):
- 26 (i) If the court finds that the convicted person has no prior
- 27 conviction within 7 years for a violation of section 82127(1), (3),

- 1 (4), or (5), former section 15a(1), (3), (4), or (5) of Act No. 74
- 2 of the Public Acts of 1968 1968 PA 74, former section 15a, or
- 3 another snowmobile substance abuse offense, the court shall order
- 4 that the person not operate a snowmobile for not less than 90 days
- 5 or more than 1 year.
- (ii) If the court finds that the person has 1 prior conviction
- 7 within 7 years for a violation of section 82127(1), (3), (4), or
- 8 (5), former section 15a(1), (3), (4), or (5) of Act No. 74 of the
- 9 Public Acts of 1968 1968 PA 74, former section 15a, or another
- 10 snowmobile substance abuse offense, the court shall order that the
- 11 person not operate a snowmobile for not less than 6 months or more
- 12 than 2 years.
- 13 (iii) If the court finds that the person has 2 or more prior
- 14 convictions within 10 ANY PERIOD OF years for a violation of
- 15 section 82127(1), (3), (4), or (5), former section 15a(1), (3),
- 16 (4), or (5) of Act No. 74 of the Public Acts of 1968 1968 PA 74,
- 17 former section 15a, or another snowmobile substance abuse offense,
- 18 the court shall order, without an expiration date, the person not
- 19 to operate a snowmobile.
- 20 (2) As used in this section, "another snowmobile substance
- 21 abuse offense" means a local ordinance substantially corresponding
- 22 to section 82127(1) or (3) or a law of another state substantially
- 23 corresponding to section 82127(1), (3), (4), or (5).
- Sec. 82143. (1) A person who operates a snowmobile is
- 25 considered to have given consent to chemical tests of his or her
- 26 blood, breath, or urine for the purpose of determining the amount
- 27 of alcohol or presence of a controlled substance, or both, in his

- 1 or her blood in all of the following circumstances:
- 2 (a) The person is arrested for a violation of section
- **3** 82127(1), (3), (4), or (5) or a local ordinance substantially
- 4 corresponding to section 82127(1) or (3).
- 5 (b) The person is arrested for negligent homicide,
- 6 manslaughter, or murder resulting from the operation of a
- 7 snowmobile, and the peace officer had reasonable grounds to believe
- 8 that the person was operating the snowmobile while impaired by, or
- 9 under the influence of, intoxicating liquor or a controlled
- 10 substance, or both, or while having a blood alcohol content of 0.10
- 11 grams or more per 100 milliliters of blood, per 210 liters of
- 12 breath, or per 67 milliliters of urine—IN VIOLATION OF SECTION
- 13 82127.
- 14 (2) A person who is afflicted with hemophilia, diabetes, or a
- 15 condition requiring the use of an anticoagulant under the direction
- 16 of a physician shall not be considered to have given consent to the
- 17 withdrawal of blood.
- 18 (3) A chemical test described in subsection (1) shall be
- 19 administered as provided in sections 82137 and 82138.
- 20 Sec. 82144. (1) If a person refuses the request of a peace
- 21 officer to submit to a chemical test offered pursuant to section
- 22 82137 or 82138, a test shall not be given without a court order,
- 23 but the officer may seek to obtain the court order.
- 24 (2) If a person refuses a chemical test offered pursuant to
- 25 section 82137 or 82138, or submits to the chemical test and the
- 26 test reveals a blood alcohol content of 0.10-0.08 grams or more per
- 27 100 milliliters of blood, per 210 liters of breath, or per 67

- 1 milliliters of urine, the peace officer who requested the person to
- 2 submit to the test shall immediately forward a written report to
- 3 the secretary of state. The report shall state that the officer had
- 4 reasonable grounds to believe that the person had committed a crime
- 5 described in section 82143(1), and either that the person has
- 6 refused to submit to the test upon the request of the peace officer
- 7 and has been advised of the consequences of the refusal or that the
- 8 test revealed a blood alcohol content of 0.10 0.08 grams or more
- 9 per 100 milliliters of blood, per 210 liters of breath, or per 67
- 10 milliliters of urine. The form of the report shall be prescribed
- 11 and furnished by the secretary of state.
- Sec. 82146. (1) If a person who refuses to submit to a
- 13 chemical test pursuant to UNDER section 82144 does not request a
- 14 hearing within 14 days of the date of notice pursuant to section
- 15 82145, the secretary of state shall issue an order that the person
- 16 not operate a snowmobile for 6 months 1 YEAR or, for a second or
- 17 subsequent refusal within 7 years, for 1 year 2 YEARS.
- 18 (2) If a hearing is requested, the secretary of state shall
- 19 hold the hearing in the same manner and under the same conditions
- 20 as provided in section 322 of the Michigan vehicle code, Act No.
- 21 300 of the Public Acts of 1949, being section 257.322 of the
- 22 Michigan Compiled Laws 1949 PA 300, MCL 257.322. A person shall not
- 23 order a hearing officer to make a particular finding on any issue
- 24 enumerated under subdivisions (a) to (d). Not less than 5 days'
- 25 notice of the hearing shall be mailed to the person requesting the
- 26 hearing, to the peace officer who filed the report under section
- 27 82144, and, if the prosecuting attorney requests receipt of the

- 1 notice, to the prosecuting attorney of the county where the arrest
- 2 was made. The hearing officer may administer oaths, issue subpoenas
- 3 for the attendance of necessary witnesses, and grant a reasonable
- 4 request for an adjournment. Not more than 1 adjournment shall be
- 5 granted to a party, and the length of an adjournment shall not
- 6 exceed 14 days. A hearing under this subsection shall be scheduled
- 7 to be held within 45 days after the date of arrest and, except for

- 18 (c) If the person refused to submit to the test upon the
- 19 request of the officer, whether the refusal was reasonable.
- 20 (d) Whether the person was advised of his or her rights under
- 21 section 82137.
- 22 (3) The hearing officer shall make a record of proceedings
- 23 held pursuant to UNDER subsection (2). The record shall be prepared
- 24 and transcribed in accordance with section 86 of the administrative
- 25 procedures act of 1969, Act No. 306 of the Public Acts of 1969,
- 26 being section 24.286 of the Michigan Compiled Laws 1969 PA 306, MCL
- 27 24.286. Upon notification of the filing of a petition for judicial

- 1 review pursuant to UNDER section 82150 and not less than 10 days
- 2 before the matter is set for review, the hearing officer shall
- 3 transmit to the court in which the petition is filed the original
- 4 or a certified copy of the official record of the proceedings. The
- 5 parties to the proceedings for judicial review may stipulate that
- 6 the record be shortened. A party unreasonably refusing to stipulate
- 7 to a shortened record may be taxed by the court in which the
- 8 petition is filed for the additional costs. The court may permit
- 9 subsequent corrections to the record.
- 10 (4) After a hearing, if the person who requested the hearing
- 11 does not prevail, the secretary of state shall order that the
- 12 person not operate a snowmobile for 6 months 1 YEAR or, for a
- 13 second or subsequent refusal within 7 years, for 1 year 2 YEARS.
- 14 The person may file a petition in the circuit court of the county
- in which the arrest was made to review the order as provided in
- 16 section 82150. If after the hearing the person who requested the
- 17 hearing prevails, the peace officer who filed the report under
- 18 section 82144 may, with the consent of the prosecuting attorney,
- 19 file a petition in the circuit court of the county in which the
- 20 arrest was made to review the determination of the hearing officer
- 21 as provided in section 82150.
- 22 Sec. 82148. (1) Upon receipt of the appropriate records of
- 23 conviction, the secretary of state shall issue an order with no
- 24 expiration date that the person not operate a snowmobile to a
- 25 person having any of the following convictions, whether under a law
- 26 of this state, a local ordinance substantially corresponding to a
- 27 law of this state, or a law of another state substantially

- 1 corresponding to a law of this state:
- 2 (a) Two convictions of a felony involving the use of a
- 3 snowmobile within 7 years.
- 4 (b) Any combination of 2 convictions within 7 years for a
- 5 violation of section 82127(1), section 15a(1) of former 1968 PA 74,
- 6 or section 15a of former 1968 PA 74, as added by 1980 PA 402.
- 7 (c) One conviction under section 82127(4) or (5) or section
- 8 15a(4) or (5) of former 1968 PA 74.
- 9 (d) Any combination of 3 convictions within 10-ANY TERM OF
- 10 years for a violation of section 82127(1) or (3), section 15a(1) or
- 11 (3) of former 1968 PA 74, or section 15a of former 1968 PA 74, as
- 12 added by 1980 PA 402.
- 13 (2) The department shall seek to enter agreements with the
- 14 appropriate agencies of other states, Canada, and provinces and
- 15 territories of Canada for the sharing of records of convictions
- 16 described in subsection (1).
- 17 (3) The secretary of state shall issue an order with no
- 18 expiration date that a person not operate a snowmobile
- 19 notwithstanding a court order issued under section 82142, or a
- 20 local ordinance substantially corresponding to section 82142. The
- 21 secretary of state shall not terminate an indefinite order issued
- 22 under this part until both of the following occur:
- 23 (a) The later of the following:
- (i) The expiration of not less than 1 year after the order was
- 25 issued.
- (ii) The expiration of not less than 5 years after the date of
- 27 a subsequent issuance of an indefinite order occurring within 7

- 1 years after the date of a prior order.
- 2 (b) The person meets the requirements of the department of
- 3 state.
- 4 (4) Multiple convictions or probate court dispositions
- 5 resulting from the same incident shall be treated as a single
- 6 violation for purposes of issuance of an order under this section.
- 7 (5) A person who is aggrieved by the issuance of an order by
- 8 the secretary of state under this section may request a hearing
- 9 with the secretary of state. The hearing shall be requested within
- 10 14 days after issuance of an order under this section by the
- 11 secretary of state. If a hearing is requested, the secretary of
- 12 state shall hold the hearing in the same manner and under the same
- 13 conditions as provided in section 322 of the Michigan vehicle code,
- 14 1949 PA 300, MCL 257.322.
- 15 (6) The hearing officer shall make a record of proceedings
- 16 held pursuant to subsection (5). The record shall be prepared and
- 17 transcribed in accordance with section 86 of the administrative
- 18 procedures act of 1969, 1969 PA 306, MCL 24.286. Upon notification
- 19 of the filing of a petition for judicial review pursuant to section
- 20 82150 and not less than 10 days before the matter is set for
- 21 review, the hearing officer shall transmit to the court in which
- 22 the petition is filed the original or a certified copy of the
- 23 official record of the proceedings. The parties to the proceedings
- 24 for judicial review may stipulate that the record be shortened. A
- 25 party unreasonably refusing to stipulate to a shortened record may
- 26 be taxed by the court in which the petition is filed for the
- 27 additional costs. The court may permit subsequent corrections to

- 1 the record.
- 2 (7) Judicial review of an administrative sanction under this
- 3 section is governed by the law in effect at the time the offense
- 4 was committed or attempted.
