- 1 SEC. 266. (1) THE OFFICE OF FEDERAL GRANTS AND PROCUREMENT IS
- 2 CREATED IN THE DEPARTMENT.
- 3 (2) THE ADMINISTRATOR OF THE OFFICE OF FEDERAL GRANTS AND
- 4 PROCUREMENT SHALL BE APPOINTED BY THE GOVERNOR.
- 5 (3) THE OFFICE OF FEDERAL GRANTS AND PROCUREMENT SHALL DO ALL
- 6 OF THE FOLLOWING:
- 7 (A) COORDINATE THE ACTIVITIES OF STATE AGENCIES TO WIN
- COMPETITIVE FEDERAL GRANTS CONSISTENT WITH THE POLICY GOALS OF THIS
- STATE.

- 1 (B) ENSURE THAT GRANTS THAT ARE AWARDED TO STATE AGENCIES ARE

- 12 FEDERAL PROCUREMENT OPPORTUNITIES AND FIND CREATIVE WAYS FOR THE
- 13 FEDERAL GOVERNMENT TO "BUY MICHIGAN".
- 14 (G) MEASURE, TRACK, AND REPORT FEDERAL FUNDING TO THE GOVERNOR
- 15 AND EACH HOUSE OF THE LEGISLATURE, EACH YEAR.
