- 4 ALLOW LAND OR A STRUCTURE ON LAND OWNED BY OR IN THE POSSESSION OF
- 5 THE PERSON TO BE USED AS A MARIHUANA BAR.
- 6 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
- 7 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS OR
  - A FINE OF NOT MORE THAN \$500.00, OR BOTH.

- 24 SERVICES, INCLUDING GOODS OR SERVICES THAT ARE NOT INCIDENTAL TO
- 25 THE USE OF MARIHUANA, AND THE PAYMENT OF MONEY OR ANY OTHER THING
- 26 OF VALUE TO BELONG TO AN ASSOCIATION OF INDIVIDUALS.
