March 4, 2009, Introduced by Senators BASHAM, BIRKHOLZ, ANDERSON, KUIPERS, JACOBS and KAHN and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 5391.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 5391. (1) A PERSON WHO DOES EITHER OF THE FOLLOWING IS
 2 GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE
 3 THAN 1 YEAR OR A FINE OF NOT MORE THAN \$1,000.00, OR BOTH:
 - (A) INSTALLS OR PLACES A TRACKING DEVICE, OR CAUSES A TRACKING DEVICE TO BE INSTALLED OR PLACED, IN OR ON A MOTOR VEHICLE WITHOUT THE KNOWLEDGE AND CONSENT OF THE OWNER OF THAT MOTOR VEHICLE OR, IF THE MOTOR VEHICLE IS LEASED, THE LESSEE OF THAT MOTOR VEHICLE.
 - (B) TRACKS THE LOCATION OF A MOTOR VEHICLE WITH A TRACKING
 DEVICE WITHOUT THE KNOWLEDGE AND CONSENT OF EITHER THE OWNER OR THE
 AUTHORIZED OPERATOR OF THAT MOTOR VEHICLE OR, IF THE MOTOR VEHICLE
