THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 286. (1) A PERSON SHALL NOT MISREPRESENT HIS OR HER
- 2 CURRENT OR FORMER MILITARY STATUS WHEN HE OR SHE MAKES ANY OF THE
- 3 FOLLOWING CLAIMS, ORALLY OR IN WRITING OR BY FALSE DISPLAY, WITH
- 4 THE INTENT TO DEFRAUD, OBTAIN EMPLOYMENT, OR BE ELECTED OR
- 5 APPOINTED TO PUBLIC OFFICE:
- 6 (A) THAT HE OR SHE IS ENTITLED TO WEAR MILITARY AWARDS,
- 7 MILITARY DECORATIONS, OR MILITARY RANK.
- B (B) THAT HE OR SHE SERVED IN THE UNITED STATES ARMED FORCES, A
- RESERVE COMPONENT OF THE UNITED STATES ARMED FORCES, OR THE

- 2 (C) THAT HE OR SHE SERVED IN THE MILITARY DURING A WARTIME
- 3 ERA, WHETHER OR NOT THERE WAS A DECLARED WAR, OR SERVED IN A COMBAT
- 4 ZONE, OR MAKES ANY OTHER MISREPRESENTATION OF ACTUAL MILITARY
- 5 SERVICE.
- 6 (2) THIS SECTION DOES NOT APPLY TO A PERSON WHO OR AN
- 7 ORGANIZATION THAT DOES 1 OR MORE OF THE FOLLOWING:
- 8 (A) REENACTS MILITARY HISTORY OR A MILITARY EVENT.

- 20 (D) WORKS AS AN EMPLOYEE OF OR VOLUNTEER FOR A MUSEUM AND, AS
- 21 A PART OF HIS OR HER DUTIES, IS REPRESENTING A MEMBER OF THE UNITED
- 22 STATES ARMED FORCES, A RESERVE COMPONENT OF THE UNITED STATES ARMED
- 23 FORCES, OR THE NATIONAL GUARD FOR CEREMONIAL, HISTORICAL, OR
- 24 TRAINING PURPOSES.
- 25 (E) OWNS, DISPLAYS, PURCHASES, SELLS, OR TRADES MILITARIA,
- 26 INCLUDING, BUT NOT LIMITED TO, MEDALS, RIBBONS, AND RANK INSIGNIA,
- 27 AND DOES NOT CLAIM TO HAVE PERSONALLY EARNED THEM UNLESS HE OR SHE

- 1 IS LEGALLY ENTITLED TO DO SO.
- 2 (F) USES HIS OR HER GIVEN NAME THAT INCLUDES A MILITARY RANK,
- 3 SO LONG AS HE OR SHE DOES NOT USE THE NAME TO DEFRAUD ANOTHER IN A
- 4 MANNER PROHIBITED BY THIS SECTION.
- 5 (G) USES A NAME OR HONORARY MILITARY OR MILITARY-LIKE RANK
- 6 THAT HAS BEEN BESTOWED UPON HIM OR HER BY A PUBLIC OFFICER, PUBLIC
- 7 EMPLOYEE, OR PUBLIC AGENCY, IN THE NAME OF A PUBLIC OFFICER OR
- 8 PUBLIC AGENCY.
- 9 (H) USES A CORPORATE, PARTNERSHIP, SOLE PROPRIETORSHIP, OR
- 10 OTHER NAME FOR A BUSINESS OR PRODUCT THAT INCLUDES A MILITARY RANK,
- 11 SO LONG AS THE NAME IS NOT USED TO DEFRAUD ANOTHER IN A MANNER
- 12 PROHIBITED BY THIS SECTION.
- 13 (I) HOLDS A REGISTERED TRADEMARK THAT INCLUDES A MILITARY RANK
- 14 OR HONORARY RANK, SO LONG AS THE TRADEMARK IS NOT USED TO DEFRAUD
- 15 ANOTHER IN A MANNER PROHIBITED BY THIS SECTION.
- 16 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
- 17 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1 YEAR, A
- 18 FINE OF NOT MORE THAN \$5,000.00, OR BOTH, AND NOT MORE THAN 100
- 19 HOURS OF COMMUNITY SERVICE, THAT SHALL BE PERFORMED IN A VETERANS
- 20 HOME OR FOR A VETERANS SERVICE ORGANIZATION.
- 21 (4) A PERSON MAY BE CHARGED WITH, CONVICTED OF, AND SENTENCED
- 22 FOR ANY OTHER VIOLATION OF LAW IN ADDITION TO THE VIOLATION OF THIS
- 23 SECTION.
- 24 (5) THIS SECTION SHALL BE KNOWN AND MAY BE CITED AS THE
- 25 "STOLEN VALOR LAW".
