A bill to amend 2008 PA 388, entitled "Beverage container redemption antifraud act," (MCL 445.631 to 445.643) by adding section 12.

- 1 IDENTIFY THE REVERSE VENDING MACHINES DESCRIBED IN THIS SUBSECTION.
- 2 (B) BY NOVEMBER 26, 2010, AND BY APRIL 1 OF EACH SUBSEQUENT
