The House was called to order by the Clerk.

The roll was called by the Clerk of the House of Representatives, who announced that a quorum was not present.

The Honorable Richard J. Brown, Clerk of the House, offered the following invocation:

"Lord, please help us learn to be strong but not rude; learn to be kind but not weak; learn to be bold but not a bully; learn to be humble, but not timid; be proud but not arrogant, develop humor without folly. For with these skills that You grant to us, we hope to serve You by doing the right thing and making the right choices for the people of Michigan. We ask this in Your name, Amen."

#### **Motions and Resolutions**

Rep. Womack offered the following resolution:

## House Resolution No. 130.

A resolution to memorialize Congress to enact the Healthy Schools Act of 2009.

Whereas, It is of vital necessity for all possible resources to be made available to address the growing and compelling health needs of our children. School-Based Health Centers (SBHC) can be invaluable avenue to provide children access to health care. For this reason, we support S. 1034, the Healthy Schools Act of 2009. This legislation would provide funding for the support of school-based health clinics. With nearly 8.7 million children without health insurance, SBHCs are providers of access to critical health care services; and

Whereas, The Healthy Schools program authorizes SBHCs to be reimbursed for providing a variety of services to children including sick visits, immunizations, mental-health services, and sports physicals. These centers are instrumental in addressing the growing need among children and adolescents for access to affordable health care. Poor health status is a critical indicator of a child's preparation to successfully function in a learning environment; and

Whereas, Michigan has 94 SBHCs located throughout the state that would benefit directly from funding provided by the Healthy Schools Act. We encourage the passage of this legislation which will greatly support the health and educational needs of the children of Michigan and across the country; now, therefore, be it

Resolved by the House of Representatives, That we memorialize the United States Congress to enact S. 1034, the Healthy Schools Act of 2009, to provide funding for the development and operation of school-based health clinics; and be it further

Resolved, That copies of this resolution be transmitted to the President of the United States Senate, the Speaker of the United States House of Representatives, and the members of the Michigan congressional delegation.

The resolution was referred to the Committee on Education.

Rep. Rick Jones offered the following resolution:

## House Resolution No. 131.

A resolution to call upon the Auditor General to identify and analyze all profits generated by the Michigan State Police Headquarters project and to report the findings to the House of Representatives.

Whereas, Transparency in government is vital to public trust, especially in the decisions that are made with regard to the spending of tax dollars. The need for full accountability becomes even more obvious at times when financial pressures result in cuts to critical services. As is the case in Michigan right now, every single decision made in Lansing is magnified when viewed through the lens of massive budgetary shortfalls; and

Whereas, The ongoing construction of the Michigan State Police Headquarters project in downtown Lansing has raised a significant public outcry, especially when the full ramifications of the recent layoff of 100 newly trained state troopers are considered; and

Whereas, The many inexplicable aspects of the Michigan State Police Headquarters project, including its origins, the premature abandonment of its current facilities, the unusual locale of the new building in light of security concerns, and longstanding opposition to the new building from some within the department make it essential that a thorough examination of finances be conducted as soon as possible. The public has every right to full disclosure; now, therefore, be it

Resolved by the House of Representatives, That we call upon the Auditor General to identify and analyze all profits generated by the Michigan State Police Headquarters project and to report the findings to the House of Representatives by August 18, 2009; and be it further

Resolved, That copies of this resolution be transmitted to the office of the Auditor General.

The resolution was referred to the Committee on Judiciary.

A bill to amend 1941 PA 258, entitled "An act to simplify the accounting procedures of the state; to provide for the state funds through which all state accounting or bookkeeping transactions are to be recorded; to provide for the discontinuance or merging of certain state funds; to adjust the accounting of payments into the highway bond sinking fund on a fiscal year basis; and to repeal all acts and parts of acts inconsistent with the provisions of this act," by amending the title and section 10 (MCL 21.110).
