

SENATE BILL No. 942

May 15, 2014, Introduced by Senators CASPERSON and KOWALL and referred to the Committee on Natural Resources, Environment and Great Lakes.

A bill to amend 1927 PA 175, entitled
 "The code of criminal procedure,"
 by amending section 13c of chapter XVII (MCL 777.13c), as amended
 by 2006 PA 59.
