A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 13402.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 13402. (1) A TANNING FACILITY SHALL REGISTER WITH THE
- 2 DEPARTMENT ON A FORM PRESCRIBED BY THE DEPARTMENT. UNLESS RENEWED
- 3 FOR AN ADDITIONAL CALENDAR YEAR, A REGISTRATION EXPIRES ON DECEMBER
- 4 31 OF THE CALENDAR YEAR FOR WHICH THE REGISTRATION FORM WAS
- 5 SUBMITTED.
 - (2) A TANNING FACILITY SHALL SUBMIT A REGISTRATION FEE WITH ITS INITIAL OR ANY RENEWAL REGISTRATION FORM OF \$75.00.
- 8 (3) IF IT RECEIVES A COMPLETE INITIAL OR RENEWAL REGISTRATION
- 9 UNDER THIS SECTION, THE DEPARTMENT SHALL ISSUE A CERTIFICATE OF
- 10 REGISTRATION TO THE TANNING FACILITY. A CERTIFICATE OF REGISTRATION

- 11 24.201 TO 24.328, THE DEPARTMENT MAY DENY, SUSPEND, OR REVOKE THE
- 12 REGISTRATION OF A TANNING FACILITY THAT VIOLATES THIS PART.
- 13 (6) A PERSON THAT VIOLATES THIS SECTION IS GUILTY OF A
- 14 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 93 DAYS OR
- 15 A FINE OF NOT MORE THAN \$2,000.00, OR BOTH, FOR EACH VIOLATION.
