- 1 Sec. 3. (1) A person shall not do any of the following:
- (a) Own or possess a large carnivore except in compliance withthis act.
 - (b) $\frac{\mbox{Breed}}{\mbox{EXCEPT}}$ AS PROVIDED IN SUBSECTION (2), BREED a large carnivore.
 - (c) Transfer ownership or possession of or receive a transfer of ownership or possession of a large carnivore, with or without remuneration, . This subdivision does not apply to a UNLESS THE transfer of ownership or possession of a large carnivore IS
