HOUSE BILL No. 5368

February 26, 2014, Introduced by Reps. Cotter, Leonard, LaFontaine, Geiss, Lauwers, Kowall and Jenkins and referred to the Committee on Judiciary.

A bill to amend 1998 PA 386, entitled
"Estates and protected individuals code,"
by amending sections 1103, 1104, 1106, and 1107 (MCL 700.1103,
700.1104, 700.1106, and 700.1107), section 1103 as amended by 2013
PA 157 and sections 1104, 1106, and 1107 as amended by 2009 PA 46.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1103. As used in this act:
- (a) "Agent" includes, but is not limited to, an attorney-in fact under a durable or nondurable power of attorney and an
 individual authorized to make decisions as a patient advocate
 concerning another's health care.
 - (b) "Application" means a written request to the probate register for an order of informal probate or informal appointment under part 3 of article III.

- 1 (c) "Attorney" means, if appointed to represent a child under
- 2 the provisions referenced in section 5213, an attorney AS THAT TERM
- 3 IS DEFINED AND serving as the child's legal advocate in the manner
- 4 defined and described in section 13a of chapter XIIA of the probate
- 5 code of 1939, 1939 PA 288, MCL 712A.13a.
- 6 (d) "Beneficiary" includes, but is not limited to, the
- 7 following:
- 8 (i) In relation to a trust, a person that is a trust
- 9 beneficiary as defined in section 7103.
- 10 (ii) In relation to a charitable trust, a person that is
- 11 entitled to enforce the trust.
- 12 (iii) In relation to a beneficiary of a beneficiary designation,
- 13 a person that is a beneficiary of an insurance or annuity policy,
- 14 of an account with POD designation, of a security registered in
- 15 beneficiary form (TOD), of a pension, profit-sharing, retirement,
- 16 or similar benefit plan, or of another nonprobate transfer at
- 17 death.
- 18 (iv) In relation to a beneficiary designated in a governing
- 19 instrument, a person that is a grantee of a deed, devisee, trust
- 20 beneficiary, beneficiary of a beneficiary designation, donee,
- 21 appointee, taker in default of a power of appointment, or person in
- 22 whose favor a power of attorney or power held in an individual,
- 23 fiduciary, or representative capacity is exercised.
- (e) "Beneficiary designation" means the naming in a governing
- 25 instrument of a beneficiary of an insurance or annuity policy, of
- 26 an account with POD designation, of a security registered in
- 27 beneficiary form (TOD), of a pension, profit-sharing, retirement,

- 1 or similar benefit plan, or of another nonprobate transfer at
- 2 death.
- 3 (f) "Child" includes, but is not limited to, an individual
- 4 entitled to take as a child under this act by intestate succession
- 5 from the parent whose relationship is involved. Child does not
- 6 include an individual who is only a stepchild, a foster child, or a
- 7 grandchild or more remote descendant.
- 8 (g) "Claim" includes, but is not limited to, in respect to a
- 9 decedent's or protected individual's estate, a liability of the
- 10 decedent or protected individual, whether arising in contract,
- 11 tort, or otherwise, and a liability of the estate that arises at or
- 12 after the decedent's death or after a conservator's appointment,
- 13 including funeral and burial expenses and costs and expenses of
- 14 administration. Claim does not include an estate or inheritance
- 15 tax, or a demand or dispute regarding a decedent's or protected
- 16 individual's title to specific property alleged to be included in
- 17 the estate.
- 18 (h) "Conservator" means a person appointed by a court to
- 19 manage a protected individual's estate.
- 20 (i) "Cost-of-living adjustment factor" means a fraction, the
- 21 numerator of which is the United States consumer price index for
- 22 the prior calendar year and the denominator of which is the United
- 23 States consumer price index for 1997. As used in this subdivision,
- 24 "United States consumer price index" means the annual average of
- 25 the United States consumer price index for all urban consumers as
- 26 defined and reported by the United States department of labor,
- 27 bureau of labor statistics, or its successor agency, and as

- 1 certified by the state treasurer.
- 2 (j) "Court" means the probate court or, when applicable, the
- 3 family division of circuit court.
- 4 (k) "Descendant" means, in relation to an individual, all of
- 5 his or her descendants of all generations, with the relationship of
- 6 parent and child at each generation being determined by the
- 7 definitions of child and parent contained in this act.
- 8 (l) "Devise" means, when used as a noun, a testamentary
- 9 disposition of real or personal property and, when used as a verb,
- 10 to dispose of real or personal property by will.
- (m) "Devisee" means a person designated in a will to receive a
- 12 devise. For the purposes of article II, for a devise to a trustee
- 13 of an existing trust or to a trustee under a will, the trustee is a
- 14 devisee and a beneficiary is not.
- 15 (N) "DIGITAL ACCOUNT" MEANS AN ELECTRONIC SYSTEM FOR CREATING,
- 16 GENERATING, SENDING, RECEIVING, STORING, DISPLAYING, OR PROCESSING
- 17 ELECTRONIC INFORMATION THAT PROVIDES ACCESS TO A DIGITAL ASSET OR A
- 18 DIGITAL SERVICE.
- 19 (O) "DIGITAL ACCOUNT HOLDER" MEANS A DECEDENT, PROTECTED
- 20 INDIVIDUAL, PRINCIPAL OF A DURABLE POWER OF ATTORNEY, OR SETTLOR
- 21 WHO HAS A TERMS-OF-SERVICE AGREEMENT WITH A DIGITAL CUSTODIAN.
- 22 (P) "DIGITAL ASSET" MEANS ELECTRONIC INFORMATION CREATED,
- 23 GENERATED, SENT, COMMUNICATED, RECEIVED, OR STORED BY ELECTRONIC
- 24 MEANS ON A DIGITAL SERVICE OR DIGITAL DEVICE. DIGITAL ACCOUNT
- 25 INCLUDES A USERNAME, WORD, CHARACTER, CODE, OR CONTRACT RIGHT UNDER
- 26 A TERMS-OF-SERVICE AGREEMENT.
- 27 (Q) "DIGITAL CUSTODIAN" MEANS A PERSON THAT ELECTRONICALLY

- 1 STORES DIGITAL PROPERTY OF A DIGITAL ACCOUNT HOLDER OR OTHERWISE
- 2 HAS CONTROL OVER DIGITAL PROPERTY OF THE DIGITAL ACCOUNT HOLDER.
- 3 (R) "DIGITAL DEVICE" MEANS AN ELECTRONIC DEVICE THAT CAN
- 4 RECEIVE, STORE, PROCESS, OR SEND DIGITAL INFORMATION.
- 5 (S) "DIGITAL PROPERTY" MEANS THE OWNERSHIP AND MANAGEMENT OF
- 6 AND RIGHTS RELATED TO A DIGITAL ACCOUNT AND DIGITAL ASSET.
- 7 (T) "DIGITAL SERVICE" MEANS THE DELIVERY OF DIGITAL
- 8 INFORMATION, SUCH AS DATA OR CONTENT, AND TRANSACTIONAL SERVICES,
- 9 SUCH AS ONLINE FORMS AND BENEFITS APPLICATIONS, ACROSS A VARIETY OF
- 10 PLATFORMS, DEVICES, AND DELIVERY MECHANISMS, SUCH AS WEBSITES,
- 11 MOBILE APPLICATIONS, AND SOCIAL MEDIA.
- 12 (U) (n) "Disability" means cause for a protective order as
- described in section 5401.
- 14 (V) (o)—"Distributee" means a person that receives a
- 15 decedent's property from the decedent's personal representative or
- 16 trust property from the trustee other than as a creditor or
- 17 purchaser. A trustee of a trust created by will is a distributee
- 18 only to the extent that distributed property or an increment of the
- 19 distributed property remains in the trustee's hands. A beneficiary
- 20 of a trust created by will to whom the trustee distributes property
- 21 received from a personal representative is a distributee of the
- 22 personal representative. For the purposes of this subdivision,
- 23 "trustee of a trust created by will" includes a trustee to whom
- 24 property is transferred by will to the extent of the devised
- 25 property.
- 26 (W) (p) "Do-not-resuscitate order" means that term as defined
- 27 in section 2 of the Michigan do-not-resuscitate procedure act, 1996

- 1 PA 193, MCL 333.1052.
- 2 Sec. 1104. As used in this act:
- 3 (A) "ELECTRONIC" MEANS RELATING TO TECHNOLOGY HAVING
- 4 ELECTRONIC, DIGITAL, MAGNETIC, WIRELESS, OPTICAL, ELECTROMAGNETIC,
- 5 OR SIMILAR CAPABILITIES.
- 6 (B) "ELECTRONIC INFORMATION" INCLUDES DATA, TEXT, IMAGES,
- 7 SOUNDS, CODES, COMPUTER PROGRAMS, SOFTWARE, AND DATABASES.
- 8 (C) "ELECTRONIC RECORD" MEANS ELECTRONIC INFORMATION THAT IS
- 9 INSCRIBED ON A TANGIBLE MEDIUM OR THAT IS STORED IN AN ELECTRONIC
- 10 OR OTHER MEDIUM AND IS RETRIEVABLE IN A PERCEIVABLE FORM.
- 11 (D) (a) "Environmental law" means a federal, state, or local
- 12 law, rule, regulation, or ordinance that relates to the protection
- 13 of the environment or human health.
- 14 (E) (b) "Estate" includes the property of the decedent, trust,
- 15 or other person whose affairs are subject to this act as the
- 16 property is originally constituted and as it exists throughout
- 17 administration. Estate also includes the rights described in
- 18 sections 3805, 3922, and 7606 to collect from others amounts
- 19 necessary to pay claims, allowances, and taxes.
- 20 (F) (e) "Exempt property" means property of a decedent's
- 21 estate that is described in section 2404.
- (G) (d) "Family allowance" means the allowance prescribed in
- 23 section 2403.
- 24 (H) (e) "Fiduciary" includes, but is not limited to, a
- 25 personal representative, guardian, conservator, trustee, plenary
- 26 guardian, partial guardian, and successor fiduciary.
- 27 (I) (f)—"Financial institution" means an organization

- 1 authorized to do business under state or federal laws relating to a
- 2 financial institution and includes, but is not limited to, a bank,
- 3 trust company, savings bank, building and loan association, savings
- 4 and loan company or association, credit union, insurance company,
- 5 and entity that offers mutual fund, securities brokerage, money
- 6 market, or retail investment accounts.
- 7 (J) (g) "Foreign personal representative" means a personal
- 8 representative appointed by another jurisdiction.
- 9 (K) (h) "Formal proceedings" means proceedings conducted

- 19 retirement, or similar benefit plan; instrument creating or
- 20 exercising a power of appointment or a power of attorney; or
- 21 dispositive, appointive, or nominative instrument of any similar
- 22 type.
- 23 (O) (l)—"Guardian" means a person who has qualified as a
- 24 guardian of a minor or a legally incapacitated individual under a
- 25 parental or spousal nomination or a court appointment and includes
- 26 a limited guardian as described in sections 5205, 5206, and 5306.
- 27 Guardian does not include a guardian ad litem.

- 1 (P) (m)—"Hazardous substance" means a substance defined as
- 2 hazardous or toxic or otherwise regulated by an environmental law.
- 3 (Q) (n)—"Heir" means, except as controlled by section 2720, a
- 4 person, including the surviving spouse or the state, that is
- 5 entitled under the statutes of intestate succession to a decedent's

- 7 (R) (O)—"Homestead allowance" means the allowance prescribed

- 9 Sec. 1106. As used in this act:
- 10 (a) "Mental health professional" means an individual who is
- 11 trained and experienced in the area of mental illness or
- 12 developmental disabilities and who is 1 of the following:
- 13 (i) A physician who is licensed to practice medicine or
- 14 osteopathic medicine and surgery in this state under article 15 of
- 15 the public health code, 1978 PA 368, MCL 333.16101 to 333.18838.

- 27 (j) "Partial guardian" means that term as defined in section

- 1 600 of the mental health code, 1974 PA 258, MCL 330.1600.
- 2 (k) "Patient advocate" means an individual designated to
- 3 exercise powers concerning another individual's care, custody, and
- 4 medical or mental health treatment or authorized to make an
- 5 anatomical gift on behalf of another individual, or both, as
- 6 provided in section 5506.
- 7 (l) "Patient advocate designation" means the written document
- 8 executed and with the effect as described in sections 5506 to 5515.
- 9 (m) "Payor" means a trustee, insurer, business entity,
- 10 employer, government, governmental subdivision or agency, or other
- 11 person authorized or obligated by law or a governing instrument to
- make payments.
- (n) "Person" means an individual or an organization.
- (o) "Personal representative" includes, but is not limited to,
- 15 an executor, administrator, successor personal representative, and
- 16 special personal representative, and any other person, other than a
- 17 trustee of a trust subject to article VII, who performs
- 18 substantially the same function under the law governing that
