- 4 HEARING AND ON ORDER OF THE DIRECTOR OF THE DEPARTMENT OF INSURANCE
- 5 AND FINANCIAL SERVICES, THE INSURER IS SUBJECT TO AN ADMINISTRATIVE
 - FINE OF \$1,000,000.00.
 - (2) THE DIRECTOR OF THE DEPARTMENT OF INSURANCE AND FINANCIAL
 - SERVICES SHALL DEPOSIT A FINE PAID UNDER THIS SECTION INTO THE
- 9 INSURANCE WHISTLEBLOWER PROTECTION FUND CREATED IN SECTION 2035A.
