(MCL 380.1 to 380.1852) by adding section 1174.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1174. (1) NOT LATER THAN JULY 1, 2015, THE DEPARTMENT
- 2 SHALL DEVELOP OR ADOPT, AND SHALL MAKE AVAILABLE TO SCHOOLS IN THIS
- 3 STATE, BOTH OF THE FOLLOWING:
- 4 (A) ONE OR MORE MODEL PROGRAMS AND RECOMMENDED CURRICULAR
 - MATERIALS CONCERNING TEEN DATING VIOLENCE AND ADOLESCENT
- 6 RELATIONSHIP ABUSE THAT ARE DESIGNED TO BE INCORPORATED INTO THE
- 7 CURRICULUM IN AN AGE- AND GRADE-APPROPRIATE MANNER.
 - (B) A MODEL POLICY FOR SCHOOLS TO USE CONCERNING REPORTING AND

- 16 DISTRICT OR BOARD OF DIRECTORS OF THE PUBLIC SCHOOL ACADEMY SHALL
- 17 NOTIFY THE PARENTS OF ALL PUPILS OF EACH SCHOOL IN WHICH THE
- 18 INSTRUCTION IS PROVIDED ABOUT THE INSTRUCTION USING THE
- 19 COMMUNICATION METHOD THE SCHOOL DISTRICT OR PUBLIC SCHOOL ACADEMY
- 20 NORMALLY USES FOR REGULAR COMMUNICATIONS WITH PARENTS.
