by amending sections 609, 614, and 618 (MCL 330.1609, 330.1614, and 330.1618).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 609. (1) A petition for the appointment of a guardian for an individual who is developmentally disabled may be filed by an interested person or entity or by the individual. The petition shall set forth the following:

- (a) The relationship and interest of the petitioner.
- (b) The name, date of birth, and place of residence of the respondent.
 - (c) The facts and reasons for the need for guardianship.
- (d) The names and addresses of the individual's current guardian, and the respondent's presumptive heirs.

- 1 (e) The name and address of the person with whom, or the
- 2 facility in which, the respondent is residing.
- 3 (f) A description and approximation of the value of the
- 4 respondent's estate including an estimate of the individual's
- 5 anticipated yearly income and the source of the income.
- 6 (g) The name, address, and age of the proposed guardian and if
- 7 the proposed guardian is a current provider of services to the
- 8 developmentally disabled.
- 9 (h) A factual description of the nature and extent of the
- 10 respondent's developmental disability.
- 11 (2) AN INTERESTED PERSON OR ENTITY OR THE INDIVIDUAL IN HIS OR
- 12 HER OWN BEHALF MAY FILE A PETITION FOR THE APPOINTMENT OF A
- 13 GUARDIAN EFFECTIVE BEGINNING ON THE INDIVIDUAL'S EIGHTEENTH
- 14 BIRTHDAY FOR AN INDIVIDUAL WHO IS DEVELOPMENTALLY DISABLED AND IS
- 15 NOT LESS THAN 17 YEARS AND 6 MONTHS OF AGE.
- 16 Sec. 614. (1) Upon the filing of a petition, the court shall
- 17 fix a date and a place for a hearing to be held within 30 days
- 18 after the filing date of the petition. IF THE RESPONDENT IS NOT
- 19 LESS THAN 17 YEARS AND 6 MONTHS OF AGE, THE COURT MAY FIX A DATE
- 20 AND A PLACE FOR THE HEARING BEFORE THE INDIVIDUAL'S EIGHTEENTH
- 21 BIRTHDAY.
- 22 (2) Hearings may be held either within or without the county
- 23 in which the court has its principal office, and in quarters as the
- 24 court directs, including a facility or other convenient place.
- 25 (3) Notice of the time and place of the hearing shall be given
- 26 to the petitioner, to the respondent, to the respondent's
- 27 presumptive heirs, to the preparer of the report or another

- 1 appropriate person who performed an evaluation, to the director of
- 2 any facility in which the respondent may be residing, to the
- 3 respondent's guardian ad litem if one has been appointed, and to
- 4 the respondent's legal counsel.
- 5 Sec. 618. (1) The court, at a hearing convened under this
- 6 chapter for the appointment of a guardian, shall do all of the
- 7 following:
- 8 (a) Inquire into the nature and extent of the general
- 9 intellectual functioning of the respondent asserted to need a
- 10 quardian.
- 11 (b) Determine the extent of the impairment in the respondent's
- 12 adaptive behavior.
- 13 (c) Determine the respondent's capacity to care for himself or
- 14 herself by making and communicating responsible decisions
- 15 concerning his or her person.
- 16 (d) Determine the capacity of the respondent to manage his or
- 17 her estate and financial affairs.
- 18 (e) Determine the appropriateness of the proposed living
- 19 arrangements of the respondent and determine whether or not it is
- 20 the least restrictive setting suited to the respondent's condition.
- 21 (f) If the respondent is residing in a facility, the court
- 22 shall specifically determine the appropriateness of the living
- 23 arrangement and determine whether or not it is the least
- 24 restrictive suited to the respondent's condition.
- 25 (2) The court shall make findings of fact on the record
- 26 regarding the matters specified in subsection (1).
- 27 (3) If it is determined that the respondent possesses the

- 1 capacity to care for himself or herself and the respondent's
- 2 estate, the court shall dismiss the petition.
- 3 (4) If it is found by clear and convincing evidence that the
- 4 respondent is developmentally disabled and lacks the capacity to do
- 5 some, but not all, of the tasks necessary to care for himself or
- 6 herself or the respondent's estate, the court may appoint a partial
- 7 quardian to provide quardianship services to the respondent, but
- 8 the court shall not appoint a plenary guardian.
- 9 (5) If it is found by clear and convincing evidence that the
- 10 respondent is developmentally disabled and is totally without
- 11 capacity to care for himself or herself or the respondent's estate,
- 12 the court shall specify that finding of fact in any order and may
- 13 appoint a plenary guardian of the person or of the estate or both
- 14 for the respondent.
- 15 (6) IF THE COURT MAKES A FINDING UNDER SUBSECTION (4) OR (5)
- 16 AND THE RESPONDENT IS NOT LESS THAN 17 YEARS AND 6 MONTHS OF AGE,
- 17 THE COURT MAY MAKE AN APPOINTMENT OF A GUARDIAN THAT IS EFFECTIVE
- 18 BEGINNING ON THE RESPONDENT'S EIGHTEENTH BIRTHDAY.
