

SENATE BILL No. 1047

September 10, 2014, Introduced by Senators GREEN, NOFS, MARLEAU, COLBECK, CASPERSON and KOWALL and referred to the Committee on Government Operations.

A bill to amend 2013 PA 240, entitled "Michigan state capitol historic site act," by amending section 6 (MCL 4.1946).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6. (1) The commission shall do all of the following:
- 2 (a) Subject to subsection (2), operate and manage the Michigan
- 3 state capitol historic site.
- 4 (b) Maintain and restore the state capitol building.
- 5 (c) Maintain and improve the grounds of the Michigan state
- 6 capitol historic site.
- 7 (d) Appoint an individual to manage the day-to-day operations
- 8 of the Michigan state capitol historic site. The individual
- 9 appointed under this subdivision is an at-will employee and ~~shall~~
- 10 ~~serve~~ **SERVES** at the pleasure of the commission.
- 11 (e) Employ staff to carry out the commission's

1 responsibilities under **THIS** subsection ~~(1)~~—and as otherwise
2 provided by law. All individuals employed by the commission are
3 nontenured, at-will employees. The commission may discipline,
4 transfer, demote, suspend, or summarily discharge an employee.

5 (f) Contract with any person for purposes of procuring goods
6 or services or otherwise carrying out the commission's
7 responsibilities with regard to the Michigan state capitol historic
8 site.

9 (g) Make recommendations to the governor, the senate, and the
10 house of representatives regarding funding for the Michigan state
11 capitol historic site, including, but not limited to, funding from
12 the fund.

13 (h) Carry out other responsibilities as provided by law.

14 **(I) WHEN SUFFICIENT MONEY IS RECEIVED TO MEET THE COSTS OF**
15 **PLACEMENT, PROVIDE FOR THE APPROPRIATE DISPLAY OF THE PLAQUE**
16 **DONATED BY BRASS ROOTS AND HONORING THE RIGHT TO BEAR ARMS UNDER**
17 **AMENDMENT II OF THE CONSTITUTION OF THE UNITED STATES AND UNDER**
18 **SECTION 6 OF ARTICLE I OF THE STATE CONSTITUTION OF 1963.**

19 (2) The commission does not have authority and shall not
20 exercise control over the internal decisions of the senate or the
21 house of representatives related to the allocation of space in the
22 state capitol building or the state capitol building parking lot,
23 including legislative or staff offices. All decisions concerning
24 space in the state capitol building and the state capitol building
25 parking lot shall be made according to the rules or practices of
26 the senate and the house of representatives.
