- Sec. 233. Sixty days prior to the public announcement of the
- 25 intention to sell any department real property, the department
- 26 shall submit notification of that intent to the subcommittees and

- 2 maintenance shall be carried forward at the end of the fiscal year

- 25 adjutant general installations; assistant adjutant general air;
- 26 senior policy executive Michigan veterans affairs agency; senior

- 1 deputy director state operations; director strategy and policy;
- 2 director public safety group; and director Michigan veterans
- 3 affairs agency.
- 4 (2) Not less than 30 days prior to the department submitting a
- 5 request for an additional unclassified employee position from the
- 6 civil service commission, or for any substantive change to the
- 7 duties of an existing unclassified employee position, the
- 8 department shall notify the subcommittees and the senate and house
- 9 fiscal agencies.

ARMORIES AND JOINT FORCE READINESS

- 11 Sec. 302. (1) From the funds appropriated in part 1 for
- 12 military operations, effective and efficient executive direction
- 13 and administrative leadership shall be provided to the department.
- 14 (2) The department shall operate and maintain National Guard
- 15 armories.

- 16 (3) The department shall evaluate armories and submit a
- 17 quarterly report on the status of the armories.
- 18 (4) The department shall maintain a system to measure the
- 19 condition and adequacy of the armories.
- 20 (5) The Michigan Army National Guard and Air National Guard
- 21 shall work to provide a culture that is free of sexual assault,
- 22 through an environment of prevention, education and training,
- 23 response capability, victim support, reporting procedures, and
- 24 appropriate accountability that enhances the safety and well-being
- 25 of all guard members.

- 12 (d) An analysis of the feasibility, potential costs, and
- 13 benefits of use of armories shared with other local, state, or
- 14 federal agencies to improve responses to local emergencies as well
- 15 as the community support provided to armories.
- 16 (e) An investment strategy and proposed funding amounts in a
- 17 prioritized project list to correct the most critical facility
- 18 shortfalls across the inventory of armories in this state.
- 19 NATIONAL GUARD TRAINING FACILITIES AND AIR BASES
- 20 Sec. 304. (1) The department shall provide Army and Air
- 21 National Guard forces, when directed, for state and local
- 22 emergencies and in support of national military requirements.
- 23 (2) The department shall operate and maintain Army National
- 24 Guard training facilities, including Fort Custer and Camp Grayling.
- 25 (3) The department shall maintain a system that measures the
- 26 condition and adequacy of air facilities using both quality and
- 27 functionality criteria.

- 1 (4) The department shall operate and maintain Air National
- 2 Guard air bases, including Selfridge Air National Guard base,
- 3 Battle Creek Air National Guard base, and Alpena combat readiness
- 4 training center.
- 5 (5) The department shall provide the following information as
- 6 provided under section 219:
- 7 (a) The apportioned and assigned strength of the Michigan Army
- 8 National Guard.
- 9 (b) The apportioned and assigned strength of the Michigan Air
- 10 National Guard.
- 11 (c) Recruiting, retention, and attrition data, including
- 12 measurement against stated performance goals, for the Michigan Army
- 13 National Guard.
- 14 (d) Recruiting, retention, and attrition data, including
- 15 measurement against stated performance goals, for the Michigan Air
- 16 National Guard.
- Sec. 305. There is hereby created and established under the
- 18 jurisdiction and control of the department a revolving account to
- 19 be known as the billeting fund account. All of the fees and other
- 20 revenues generated from the operation of the chargeable transient
- 21 quarters program shall be deposited in the billeting fund account.
- 22 Appropriations will be made from the account for the support of
- 23 program operations and the maintenance and operations of the
- 24 chargeable transient quarters program and will not exceed the
- 25 estimated revenues for the fiscal year in which they are made,
- 26 together with unexpended balances from prior years. The department
- 27 shall submit an annual report of operations and expenditures

- 1 regarding the billeting fund account to the appropriations
- 2 committees of the senate and house of representatives, the house

- 7 challeNGe academy to provide values, skills, education, and self-
- 8 discipline instruction for at-risk youth as provided under 32 USC
- **9** 509.
- 10 (2) The department shall take steps to recruit candidates to
- 11 the challeNGe program from economically disadvantaged areas,
- 12 including those with low-income and high-unemployment backgrounds.
- 13 (3) The department shall partner with the department of health
- 14 and human services to identify youth who may be eligible for the
- 15 challeNGe program from those youth served by department of health
- 16 and human services programs. These eligible youth shall be given
- 17 priority for enrollment in the program.

24 MILITARY FAMILY RELIEF FUND

- 25 Sec. 308. (1) The department shall provide grants for
- 26 disbursement from the military family relief fund, as provided
- 27 under the military family relief fund act, 2004 PA 363, MCL 35.1211

- 1 to 35.1216, and R 200.5 to R 200.95 of the Michigan administrative
- 2 code.
- 3 (2) The department shall provide information on the revenues,
- 4 expenditures for advertising and assistance grants, and fund
- 5 balance of the Michigan military family relief fund, as provided
- 6 under section 219.
- 7 (3) The department shall provide sufficient staffing and other
- 8 resources to provide outreach to the Michigan families of members
- 9 of the reserve component of the armed forces called into active
- 10 duty and to support the processing and approval of at least 60
- 11 grant applications this fiscal year under the Michigan military
- 12 relief fund and report those applications as provided in section
- **13** 219.

14 STARBASE GRANT

- via an IDG to the department of technology, management, and budget
- 23 for technology services, including maintenance and repair services,
- 24 and technology projects, to maximize the operational efficiency and
- 25 effectiveness of the department.

1 MICHIGAN VETERANS AFFAIRS AGENCY ADMINISTRATION

- 2 Sec. 400. (1) The MVAA agency shall provide outreach services
- 3 to Michigan veterans that advise them on the benefits to which they
- 4 are entitled, as provided under Executive Reorganization Order No.
- 5 2013-2, MCL 32.92. The MVAA shall also do the following:
- **6** (a) Maintain the staffing partnerships and other resources
- 7 necessary to develop and operate an outreach program that will

- 19 military discharge documents, and burial records that are currently
- 20 on paper and microfilm.
- 21 (e) Provide a report, as provided under section 219, on the
- 22 MVAA's performance on the performance measures, outcomes, and
- 23 initiatives developed by the agency in the strategic plan required
- 24 by section 501 of 2013 PA 9.
- 25 (f) Provide a report to the subcommittees, senate and house
- 26 fiscal agencies, and the state budget office no later than April 1
- 27 providing for the following:

- 1 (i) To the extent known, data on the estimated number of
- 2 homeless veterans, by county, in this state.
- 3 (ii) A summary of the activities and strategies developed to
- 4 date under the MVAA community assessment and regional service
- 5 delivery model pilot.
- 6 (2) From the funds appropriated in part 1, the MVAA shall
- 7 provide for the regional coordination of services, as follows:
- 8 (a) Regional coordinators shall be selected by the MVAA
- 9 through a grant agreement with VSOs or by other means.
- 10 (b) Regional coordinators shall provide the following
- 11 services:
- 12 (i) Coordinate veteran benefit counselors' efforts throughout

- 23 system.
- 24 (3) The MVAA shall report the following information as
- 25 provided in section 219:
- 26 (a) A summary of activities supported through the
- 27 appropriation in part 1 for veterans service organization grants,

- 1 including separately for each service region, the amount of
- 2 expenditures to date, number of service hours, number of claims for
- 3 benefits submitted by type of claim, and other information deemed
- 4 appropriate by the MVAA.
- 5 (b) The number of fully developed claims, by type, submitted
- 6 to the USDVA by veterans service organizations, with an overall
- 7 goal of 40% of benefit claims submitted that are considered fully
- 8 developed by the USDVA.

9 VETERANS' TRUST FUND ADMINISTRATION

- 7 (2) The department shall provide resources necessary to
- 8 provide nursing care services to veterans in accordance with
- 9 federal standards, including the following:
- 10 (a) A licensed minimum number of 403 residents in skilled
- 11 nursing beds at the Grand Rapids home for veterans.
- 12 (b) A licensed minimum number of 72 residents in domiciliary
- 13 beds at the Grand Rapids home for veterans.
- 14 (3) Appropriations in part 1 for the Grand Rapids home for
- 15 veterans shall not be used for any purpose other than for veterans
- 16 and veterans' families.
- 17 (4) Any contractor providing competency evaluated nursing
- 18 assistants (CENA) to the Grand Rapids home for veterans shall
- 19 ensure that each CENA has at least 8 hours of training on
- 20 information provided by the home.
- 21 (5) Any contractor providing competency evaluated nursing
- 22 assistants to the Grand Rapids home for veterans shall ensure that
- 23 each CENA has at least 1 eight-hour shift of shadowing at the
- 24 veterans' home.
- 25 (6) Any contractor providing competency evaluated nursing

- 2 (4) Any contractor providing competency evaluated nursing
