A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

(MCL 600.101 to 600.9947) by adding section 1832.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1832. (1) AN INDIVIDUAL WHO IS IN CHARGE OF A BUSINESS
- 2 ESTABLISHMENT SHALL GRANT ENTRY INTO THE ESTABLISHMENT, OR
- 3 OTHERWISE MAKE EMPLOYEES, AGENTS, OR INVITEES OF THE ESTABLISHMENT
- 4 AVAILABLE, TO A PROCESS SERVER WHEN THE PROCESS SERVER IS AT THE
- 5 ESTABLISHMENT FOR THE PURPOSE OF SERVING PROCESS ON A DEFENDANT OR
- 6 WITNESS WHO IS KNOWN TO BE IN THE ESTABLISHMENT.
- 7 (2) A GATE ATTENDANT OR OTHER INDIVIDUAL WHO HAS THE AUTHORITY
- 8 TO DETERMINE WHO MAY ENTER A GATED RESIDENTIAL COMMUNITY SHALL
  - GRANT ENTRY INTO THE COMMUNITY, INCLUDING ITS COMMON AREAS AND
- 10 COMMON ELEMENTS, TO A PROCESS SERVER TO SERVE PROCESS ON A
  - DEFENDANT OR WITNESS WHO RESIDES IN OR IS KNOWN TO BE IN THE

- 2 (3) AN INDIVIDUAL WHO VIOLATES THIS SECTION BY REFUSING ENTRY
- 3 TO A PROCESS SERVER OR WHO KNOWINGLY REFUSES TO ASSIST A PROCESS
- 4 SERVER BY FAILING OR REFUSING TO MAKE AN EMPLOYEE AVAILABLE FOR
- 5 SERVICE OF PROCESS DURING THE EMPLOYEE'S WORK HOURS IS GUILTY OF A
- 6 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 93 DAYS OR
- 7 A FINE OF NOT MORE THAN \$500.00, OR BOTH.
- 8 (4) AS USED IN THIS SECTION:
- 9 (A) "BUSINESS ESTABLISHMENT" MEANS REAL PROPERTY BEING USED
- 10 FOR A COMMERCIAL OR INDUSTRIAL PURPOSE.
- 11 (B) "GATED RESIDENTIAL COMMUNITY" INCLUDES A CONDOMINIUM
- 12 ASSOCIATION, HOUSING COOPERATIVE, OR PRIVATE COMMUNITY.
- 13 (C) "PROCESS SERVER" MEANS A PERSON AUTHORIZED UNDER THIS ACT
- 14 OR SUPREME COURT RULE TO SERVE PROCESS.
