A bill to amend 1995 PA 30, entitled

"Electric transmission line certification act,"

by amending section 2 (MCL 460.562), as amended by 2004 PA 198.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- 2 (a) "Affiliated transmission company" means a person,
- 3 partnership, corporation, association, or other legal entity, or
- 4 its successors or assigns, which THAT has fully satisfied the
- 5 requirements to join a regional transmission organization as
- 6 determined by the federal energy regulatory commission, FEDERAL
 - ENERGY REGULATORY COMMISSION, is engaged in this state in the
- 8 transmission of electricity using facilities it owns that were
- 9 transferred to the entity by an electric utility that was engaged

- 1 in the generation, transmission, and distribution of electricity in
- 2 this state on December 31, 2000, and is not independent of an
- 3 electric utility or an affiliate of the utility, generating or
- 4 distributing electricity to retail customers in this state.
- 5 (b) "Certificate" means a certificate of public convenience
- 6 and necessity issued for a major transmission line under this act
- 7 or issued for a transmission line under section 9.
- 8 (c) "Commission" means the Michigan public service commission.
- 9 (d) "Construction" means any substantial action taken on a
- 10 route constituting placement or erection of the foundations or
- 11 structures supporting a transmission line. Construction does not
- 12 include preconstruction activity or the addition of circuits to an
- 13 existing transmission line.
- 14 (e) "Electric utility" means a person, partnership,
- 15 corporation, association, or other legal entity whose transmission
- 16 or distribution of electricity the commission regulates under 1909
- 17 PA 106, MCL 460.551 to 460.559, or 1939 PA 3, MCL 460.1 to
- 18 460.10cc. 460.11. Electric utility does not include a municipal
- 19 utility, affiliated transmission company, or independent
- 20 transmission company.
- 21 (f) "Independent transmission company" means a person,
- 22 partnership, corporation, association, or other legal entity, or
- 23 its successors or assigns, THAT IS engaged in this state OR IS
- 24 PROPOSING TO BE ENGAGED in the transmission of electricity using
- 25 facilities it owns that have been divested to the entity by an
- 26 electric utility that was engaged in the generation, transmission,
- 27 and distribution of electricity in this state on December 31, 2000,

- 1 and THAT is independent of an electric utility or NOT an affiliate
- 2 of the AN ELECTRIC utility , generating or distributing electricity
- 3 to retail customers in this state.
- 4 (g) "Major transmission line" means a transmission line of 5
- 5 miles or more in length wholly or partially owned by an electric
- 6 utility, affiliated transmission company, or independent
- 7 transmission company through which electricity is transferred at
- 8 system bulk supply voltage of 345 kilovolts or more.
- 9 (h) "Municipality" means a city, township, or village.
- 10 (i) "Preconstruction activity" means any activity on a
- 11 proposed route conducted before construction of a transmission line
- 12 begins. Preconstruction activity includes surveys, measurements,
- 13 examinations, soundings, borings, sample-taking, or other testing
- 14 procedures, photography, appraisal, or tests of soil, groundwater,
- 15 structures, or other materials in or on the real property for
- 16 contamination. Preconstruction activity does not include an action
- 17 that permanently or irreparably alters the real property on or
- 18 across the proposed route.
- 19 (j) "Route" means real property on or across which a
- 20 transmission line is constructed or proposed to be constructed.
- 21 (k) "Transmission line" means all structures, equipment, and
- 22 real property necessary to transfer electricity at system bulk
- 23 supply voltage of 100 kilovolts or more.
