February 18, 2015, Introduced by Senator HUNE and referred to the Committee on Agriculture.

A bill to amend 2000 PA 274, entitled "Large carnivore act,"

by amending section 22 (MCL 287.1122), as amended by 2013 PA 8.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 22. (1) Sections 4, 5, and 6 do not apply to any of the 2 following:
 - (a) An animal control shelter or animal protection shelter

 TEMPORARILY IN POSSESSION OF A LARGE CARNIVORE FOR NOT MORE THAN 45

 DAYS.
 - (b) A person licensed or approved by the department of natural resources of this state or by the United States fish and wildlife service of the United States department of the interior. This subdivision does not apply to a person in possession of 1 or more

- 3 (c) A zoological park approved or accredited by the American
- 4 zoo and aquarium association.
- 5 (d) A person approved by the association of sanctuaries or the

- 7 (C) (e)—A law enforcement officer acting under the authority

- 9 (D) (f) A veterinarian temporarily in possession of a large

- 2 (ii) A PERSON APPROVED BY THE AMERICAN SANCTUARY ASSOCIATION.
- 3 (c) Meets or exceeds all standards, including but not limited
- 4 to standards for training, housing, care, and transport of large
- 5 carnivores, required of a CLASS A LICENSEE OR class C licensee
- 6 under 9 CFR parts 1 and 2.
- 7 (d) Except as provided in subsection (4), does not allow a
- 8 patron to do any of the following:
- 9 (i) Come into direct contact with a large carnivore.
- 10 (ii) Come into close enough contact with a large carnivore over
- 11 20 weeks of age so as to place the patron in jeopardy of being
- 12 harmed by the large carnivore.
- 13 (e) Does not sell large carnivores, except to another person
- 14 that meets the requirements of this subsection.
- 15 (f) Does not breed ONLY BREEDS large carnivores IF APPROVED OR
- 16 ACCREDITED BY THE AMERICAN ZOO AND AQUARIUM ASSOCIATION OR BY THE
- 17 ZOOLOGICAL ASSOCIATION OF AMERICA.
- 18 (4) This act does not apply to a person who allows a patron to
- 19 come into contact with a large carnivore under subsection (3) (d) (i)
- 20 or (ii) if the large carnivore is a bear less than 36 weeks of age
- 21 or a bear weighing 90 pounds or less if the person otherwise meets
- 22 the requirements of subsection (3) and satisfies 1 of the
- 23 following:
- 24 (a) The person was in possession of a bear on the effective
- 25 date of the 2013 amendatory act that amended this section. MARCH 26,
- 26 2013.
- 27 (b) The person acquired a business described in subsection
