

SENATE BILL No. 199

March 12, 2015, Introduced by Senator WARREN and referred to the Committee on Natural Resources.

A bill to amend 1976 IL 1, entitled

"A petition to initiate legislation to provide for the use of returnable containers for soft drinks, soda water, carbonated natural or mineral water, other nonalcoholic carbonated drink, and for beer, ale, or other malt drink of whatever alcoholic content, and for certain other beverage containers; to provide for the use of unredeemed bottle deposits; to prescribe the powers and duties of certain state agencies and officials; and to prescribe penalties and provide remedies,"

by amending section 1 (MCL 445.571), as amended by 1989 PA 93.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. As used in this act:

2 (a) "Beverage" means ~~a soft drink, soda~~ **OR OTHER CARBONATED OR**
3 **NONCARBONATED** water; ~~, carbonated natural or mineral water, or~~
4 ~~other nonalcoholic carbonated drink, beer, ale, or other malt drink~~
5 of whatever alcoholic content; ~~or a mixed wine drink or a mixed~~
6 spirit drink; **OR A NONALCOHOLIC CARBONATED OR NONCARBONATED DRINK**
7 **IN LIQUID FORM AND INTENDED FOR INTERNAL HUMAN CONSUMPTION, EXCEPT**

1 FOR UNFLAVORED RICE MILK, UNFLAVORED SOYMILK, MILK, OR A DAIRY-
2 DERIVED PRODUCT.

3 (b) "Beverage container" means ~~an~~ **1 OF THE FOLLOWING:**

4 (i) **AN** airtight metal, glass, paper, or plastic container, or a
5 container composed of a combination of these materials, which ~~at~~
6 the time of sale ~~contains~~ 1 gallon or less of a beverage **OTHER**
7 **THAN A NONALCOHOLIC BEVERAGE.**

8 (ii) **AN AIRTIGHT METAL, GLASS, OR PLASTIC CONTAINER WHICH AT**
9 **THE TIME OF SALE CONTAINS 1 GALLON OR LESS OF A NONALCOHOLIC**
10 **BEVERAGE OTHER THAN A CONTAINER COMPOSED IN WHOLE OR IN PART OF**
11 **ALUMINUM AND PLASTIC OR ALUMINUM AND PAPER IN COMBINATION IF THE**
12 **ALUMINUM CONTENT REPRESENTS 10% OR LESS OF THE UNFILLED CONTAINER**
13 **WEIGHT AND THE UNFILLED CONTAINER WEIGHT IS 5% OR LESS OF THE**
14 **FILLED CONTAINER WEIGHT.**

15 (c) "Empty returnable container" means a beverage container
16 ~~which~~ **THAT** contains nothing except the residue of its original
17 contents.

18 (d) "Returnable container" means a beverage container ~~upon~~ **ON**
19 which a deposit of ~~at least~~ **NOT LESS THAN** 10 cents has been paid,
20 or is required to be paid upon the removal of the **BEVERAGE**
21 container from the sale or consumption area, and for which a refund
22 of ~~at least~~ **NOT LESS THAN** 10 cents in cash is payable by every
23 dealer or distributor in this state of that beverage in beverage
24 containers, as further provided in section 2.

25 (e) "Nonreturnable container" means a beverage container ~~upon~~
26 **ON** which no deposit or a deposit of less than 10 cents has been
27 paid, or is required to be paid, ~~upon the removal of~~ **IF** the

1 **BEVERAGE** container **IS REMOVED** from the sale or consumption area, or
2 for which no cash refund or a refund of less than 10 cents is
3 payable by a dealer or distributor in this state of that beverage
4 in beverage containers, as further provided in section 2.

5 (f) "Person" means an individual, partnership, corporation,
6 **LIMITED LIABILITY COMPANY**, association, or other legal entity.

7 (g) "Dealer" means a person ~~who~~**THAT** sells or offers for sale
8 to consumers within this state a beverage in a beverage container,
9 including an operator of a vending machine containing a beverage in
10 a beverage container.

11 (h) "Operator of a vending machine" means equally its owner,
12 the person ~~who~~**THAT** refills it, and the owner or lessee of the
13 property upon which it is located.

14 (i) "Distributor" means a person, ~~who~~**INCLUDING A**
15 **MANUFACTURER, THAT** sells beverages in beverage containers to a
16 dealer within this state. ~~, and includes a manufacturer who engages~~
17 ~~in such sales.~~

18 (j) "Manufacturer" means a person ~~who~~**THAT** bottles, cans, or
19 otherwise places beverages in beverage containers for sale to
20 distributors, dealers, or consumers.

21 (k) "Within this state" means within the exterior limits of
22 the state of Michigan, and includes the territory within these
23 limits owned by or ceded to the United States of America.

24 (l) "Commission" means the ~~Michigan~~ liquor control commission
25 **CREATED IN SECTION 209 OF THE MICHIGAN LIQUOR CONTROL CODE OF 1998,**
26 **1998 PA 58, MCL 436.1209.**

27 (m) "Sale or consumption area" means the premises ~~within~~**ON**

1 the property of the dealer or of the dealer's lessor where the sale
2 is made, ~~within which~~ **WHERE** beverages in returnable containers may
3 be consumed without payment of a deposit, and ~~, upon removing a~~
4 ~~beverage container from which, the customer is required by~~ **FROM**
5 **WHICH A CONSUMER MAY NOT REMOVE A BEVERAGE CONTAINER WITHOUT** the
6 dealer **REQUIRING HIM OR HER** to pay ~~the~~ **A** deposit.

7 (n) "Nonrefillable container" means a returnable container
8 ~~which~~ **THAT** is not intended to be refilled for sale by a
9 manufacturer.

10 (o) "Mixed wine drink" means a drink or similar product
11 marketed as a wine cooler and containing less than 7% alcohol by
12 volume, consisting of wine and plain, sparkling, or carbonated
13 water and containing any 1 or more of the following:

14 (i) Nonalcoholic beverages.

15 (ii) Flavoring.

16 (iii) Coloring materials.

17 (iv) Fruit juices.

18 (v) Fruit adjuncts.

19 (vi) Sugar.

20 (vii) Carbon dioxide.

21 (viii) Preservatives.

22 (p) "Mixed spirit drink" means a drink containing 10% or less
23 alcohol by volume consisting of distilled spirits mixed with
24 nonalcoholic beverages or flavoring or coloring materials and ~~which~~
25 **THAT** may also contain water, fruit juices, fruit adjuncts, sugar,
26 carbon dioxide, or preservatives; or ~~any~~ **A** spirits based beverage,
27 regardless of the percent of alcohol by volume, that is

1 manufactured for sale in a metal BEVERAGE container.

2 (Q) "UNFLAVORED RICE MILK" MEANS A LIQUID THAT CONTAINS NO
3 ADDITIONAL FLAVORING INGREDIENTS AND IS INTENDED FOR INTERNAL HUMAN
4 CONSUMPTION, THE PRIMARY PROTEIN SOURCE OF WHICH IS RICE PROTEIN
5 DERIVED FROM PARTIALLY MILLED BROWN RICE.

6 (R) "UNFLAVORED SOYMILK" MEANS A LIQUID THAT CONTAINS NO
7 ADDITIONAL FLAVORING INGREDIENTS AND IS INTENDED FOR INTERNAL HUMAN
8 CONSUMPTION, THE PRIMARY PROTEIN SOURCE OF WHICH IS SOY PROTEIN
9 DERIVED FROM WHOLE SOYBEANS, ISOLATED SOY PROTEIN, SOY PROTEIN
10 CONCENTRATE, SOY FLOUR, SPRAY-DRIED TOFU, OR SPRAY-DRIED SOYMILK.

11 Enacting section 1. This amendatory act takes effect January
12 1, 2016.
