SENATE BILL No. 1066

September 8, 2016, Introduced by Senators JONES and PROOS and referred to the Committee on Regulatory Reform.

A bill to amend 1915 PA 31, entitled "Youth tobacco act,"

(MCL 722.641 to 722.645) by amending the title and by adding section 3a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 TITLE

An act to prohibit the selling, giving, or furnishing of tobacco products to minors; to prohibit the purchase, possession, or use of tobacco products by minors; to regulate the retail sale of tobacco products; to prescribe penalties; and to prescribe the powers and duties of certain state agencies and departments; AND TO PREEMPT LOCAL UNITS OF GOVERNMENT FROM REGULATING CERTAIN CONDUCT.

SEC. 3A. (1) A LOCAL UNIT OF GOVERNMENT SHALL NOT ADOPT OR

- 17 A COUNTY, TOWNSHIP, CITY, OR VILLAGE OF THIS STATE.
- 18 Enacting section 1. This amendatory act takes effect 90 days
- 19 after the date it is enacted into law.
