A bill to establish and implement a veterans service dog grant program; to create a fund; and to prescribe the powers and duties of certain state agencies and officials.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as the
 "veterans service dog act".
- 3 Sec. 2. As used in this act:
 - (a) "Department" means the department of military and veterans affairs.
 - (b) "Fund" means the veterans service dog fund created in section 4.
 - (c) "Grant program" means the veterans service dog grant program established in section 3.
 - (d) "Person" means an individual, partnership, corporation,

- 1 association, governmental entity, or other legal entity.
- 2 (e) "Service dog" means a dog that is trained to do work or
- 3 perform tasks for an individual with a disability, including a
- 4 physical, sensory, psychiatric, intellectual, or other mental
- 5 disability. The work done or tasks performed must be directly
- 6 related to the individual's disability and may include, but are not
- 7 limited to, guiding an individual who is visually impaired or
- 8 blind, alerting an individual who is deaf or has difficulty
- 9 hearing, pulling a wheelchair, assisting with mobility or balance,
- 10 alerting and protecting an individual who is having a seizure,
- 11 retrieving objects, alerting an individual to the presence of
- 12 allergens, providing physical support and assistance with balance
- 13 and stability to an individual with a mobility disability, helping
- 14 an individual with a psychiatric or neurological disability by
- 15 preventing or interrupting impulsive or destructive behaviors,
- 16 reminding an individual with mental illness to take prescribed
- 17 medications, calming an individual with posttraumatic stress
- 18 disorder during an anxiety attack, or doing other specific work or
- 19 performing other special tasks. A service dog is not a pet. For
- 20 purposes of this subdivision, "do work or perform tasks" does not
- 21 include the crime-deterrent effect of an animal's presence or the
- 22 provision of emotional support, well-being, comfort, or
- 23 companionship.
- 24 (f) "Service dog provider" means a person in the business of
- 25 training service dogs for sale.
- 26 (g) "Veteran" means that term as it is defined in section 1 of
- 27 1965 PA 190, MCL 35.61.

- 1 Sec. 3. (1) The department shall establish and implement a
- 2 veterans service dog grant program that uses money from the fund to
- 3 provide grants for the acquisition of service dogs for veterans.
- 4 (2) The grant program must require that a veteran applying to
- 5 receive a grant contribute at least 50% of the cost of the service
- 6 dog, but not more than \$3,000.00.
- 7 (3) A veteran who wishes to apply for a grant shall submit an
- 8 application to the department containing the information required
- 9 by the department, including all of the following:
- 10 (a) The name, address, and other contact information of the
- 11 service dog provider that will be providing the service dog.
- 12 (b) The total cost of purchase of the service dog.
- 13 (c) The amount of the grant that is being requested.
- 14 (d) The amount that the veteran will be contributing toward
- 15 the purchase of the service dog and documentation of the source of
- 16 the veteran's contribution.
- 17 (e) A letter in support of the grant from a congressionally
- 18 chartered veterans' organization or other organization approved by
- 19 the department.
- 20 (4) If the department approves a grant, the department shall
- 21 notify the veteran. Upon confirmation that the veteran has paid the
- 22 veteran's share of the cost of the service dog, the department
- 23 shall disburse the grant funds to the service dog provider.
- Sec. 4. (1) The veterans service dog fund is created within
- 25 the state treasury.
- 26 (2) The state treasurer may receive money or other assets from
- 27 any source for deposit into the fund. The state treasurer shall

- 1 direct the investment of the fund. The state treasurer shall credit
- 2 to the fund interest and earnings from fund investments.
- 3 (3) The fund must have an accumulated principal limitation of
- 4 \$5,000,000.00, exclusive of interest and earnings. Any money
- 5 received by the fund after the fund reaches its accumulated
- 6 principal limitation must be forwarded to the state treasurer for
- 7 deposit into the Michigan veterans' trust fund established in
- 8 section 37 of article IX of the state constitution of 1963.
- **9** (4) Money in the fund at the close of the fiscal year remains
- 10 in the fund and does not lapse to the general fund.
- 11 (5) The department shall be the administrator of the fund for
- 12 auditing purposes.
- 13 (6) The department shall expend money from the fund, upon
- 14 appropriation, only for the following:
- 15 (a) Grants issued pursuant to the grant program.
- 16 (b) Not more than 10% of the money appropriated from the fund
- 17 for the employment of not more than 1 FTE to administer the grant
- 18 program.
- 19 Sec. 5. At least every 5 years, the department shall prepare a
- 20 report for the reporting period that describes the money received
- 21 by the fund, the balance of the fund, the total expenditures from
- 22 the fund, and the number of grants issued with money from the fund.
- 23 The department shall provide this report to the standing committees
- 24 of each house of the legislature with jurisdiction over veterans
- 25 issues.
- 26 Enacting section 1. This act takes effect 90 days after the
- 27 date it is enacted into law.
