March 8, 2017, Introduced by Reps. Noble, Glenn, Barrett, Miller, Bellino, Theis, Kelly, VanderWall, Kahle and Howell and referred to the Committee on Judiciary.

A bill to amend 1846 RS 83, entitled "Of marriage and the solemnization thereof," (MCL 551.1 to 551.18) by adding section 8.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 8. (1) A MINISTER OF THE GOSPEL, CLERIC, OR RELIGIOUS
- 2 PRACTITIONER IS NOT REQUIRED TO SOLEMNIZE OR RECOGNIZE A MARRIAGE
- 3 THAT VIOLATES HIS OR HER CONSCIENCE OR RELIGIOUS BELIEFS. A
- 4 MINISTER OF THE GOSPEL, CLERIC, OR RELIGIOUS PRACTITIONER IS IMMUNE
- 5 FROM ANY CIVIL CLAIM OR CAUSE OF ACTION BASED ON A REFUSAL TO
 - SOLEMNIZE OR RECOGNIZE A MARRIAGE THAT VIOLATES HIS OR HER
- 7 CONSCIENCE OR RELIGIOUS BELIEFS.
 - (2) AS USED IN THIS SECTION:
- 9 (A) "MINISTER OF THE GOSPEL, CLERIC, OR RELIGIOUS
- 10 PRACTITIONER" INCLUDES AN INDIVIDUAL WHO IS ORDAINED BY A RELIGIOUS

11 ORGANIZATION.

- 1 (B) "RECOGNIZE" MEANS TO PROVIDE RELIGIOUS-BASED SERVICES THAT
- 2 ARE BOTH OF THE FOLLOWING:
- 3 (i) DELIVERED BY A RELIGIOUS ORGANIZATION OR BY AN INDIVIDUAL
- 4 WHO IS AFFILIATED WITH, SUPERVISED, OR DIRECTED BY A RELIGIOUS
- 5 ORGANIZATION.
- 6 (ii) DESIGNED FOR A MARRIED COUPLE OR A COUPLE ENGAGED TO
- 7 MARRY AND DIRECTLY RELATED TO SOLEMNIZING, CELEBRATING,
- 8 STRENGTHENING, OR PROMOTING A MARRIAGE, SUCH AS RELIGIOUS
- 9 COUNSELING PROGRAMS, COURSES, RETREATS, WORKSHOPS, AND SERVICES

- 11 (C) "RELIGIOUS ORGANIZATION" MEANS A CHURCH, SEMINARY,
- 12 SYNAGOGUE, TEMPLE, MOSQUE, RELIGIOUS ORDER, RELIGIOUS CORPORATION,
- 13 ASSOCIATION, OR SOCIETY WHOSE IDENTITY IS DISTINCTIVE IN TERMS OF
- 14 COMMON RELIGIOUS CREED, BELIEFS, DOCTRINES, PRACTICES, OR RITUALS
- 15 OF ANY FAITH OR DENOMINATION, INCLUDING A FOR-PROFIT ORGANIZATION
- 16 AND ANY ORGANIZATION QUALIFYING AS A CHURCH OR RELIGIOUS
- 17 ORGANIZATION UNDER SECTION 501(C)(3) OR 501(D) OF THE UNITED STATES
- 18 INTERNAL REVENUE CODE OF 1986.
- 19 Enacting section 1. This amendatory act takes effect 90 days
- 20 after the date it is enacted into law.
