

HOUSE BILL No. 4381

March 21, 2017, Introduced by Rep. Wentworth and referred to the Committee on Military and Veterans Affairs.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending sections 74116 and 78119 (MCL 324.74116 and 324.78119),
section 74116 as amended by 2016 PA 1 and section 78119 as amended
by 2013 PA 81.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 74116. (1) Subject to subsection (4), the operator of a
2 nonresident motor vehicle or commercial motor vehicle shall not
3 enter any state park with that motor vehicle unless a valid motor
4 vehicle park permit issued under section 74117 is affixed to the
5 lower right-hand corner of the windshield. An annual motor vehicle
6 park permit for a nonresident motor vehicle shall be affixed
7 permanently for that year. The department shall post signs at parks
8 that state that a motor vehicle park permit is required for entry
9 by a nonresident motor vehicle or commercial motor vehicle.

1 (2) Subject to subsection (4), the operator of a resident
2 motor vehicle shall not enter a state park with the resident motor
3 vehicle unless the recreation passport fee has been paid **OR IS**
4 **CONSIDERED TO HAVE BEEN PAID** for that motor vehicle **AS PROVIDED IN**
5 **SECTION 805 OF THE MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.805.**
6 Payment of the recreation passport fee authorizes entry into all
7 state parks and recreation areas and designated state-operated
8 public boating access sites until expiration of the motor vehicle
9 registration.

10 (3) Subject to subsection (4), if the secretary of state
11 issues registration tabs or stickers as described in section 805 of
12 the Michigan vehicle code, 1949 PA 300, MCL 257.805, the operator
13 of a resident motor vehicle shall not enter a state park with the
14 resident motor vehicle unless the resident motor vehicle has a
15 registration tab or sticker marked as provided under that section
16 to show that the recreation passport fee has been paid **OR IS**
17 **CONSIDERED TO HAVE BEEN PAID AS PROVIDED IN THAT SECTION.**

18 (4) Subsections (1) to (3) do not apply under any of the
19 following circumstances:

20 (a) While the motor vehicle is being driven or parked within
21 an established federal ~~, OR state , or county~~ highway **OR COUNTY**
22 **ROAD** within a state park.

23 (b) If the motor vehicle is used in the operation or
24 maintenance of a state park, is an emergency motor vehicle, is a
25 state owned or law enforcement motor vehicle, or is a private motor
26 vehicle being operated on official state business.

27 (c) If the motor vehicle is registered under section 803e(1)

1 of the Michigan vehicle code, 1949 PA 300, MCL 257.803e, and is
2 exempt under section 803e(6) of the Michigan vehicle code, 1949 PA
3 300, MCL 257.803e, from the registration tax, or if the motor
4 vehicle is registered under section 217d or 803f of the Michigan
5 vehicle code, 1949 PA 300, MCL 257.217d and 257.803f.

6 (d) At a state-operated public boating access site or a state
7 park where there is an opportunity to fish on a day that the
8 department has designated as a free winter fishing day or a free
9 fishing day under section 43534.

10 (e) If and to the extent that the department waives the
11 requirements for department-sponsored events or other circumstances
12 as determined by the director or the director's designee.

13 Sec. 78119. (1) Subject to subsection (4), a person shall not
14 enter, in a nonresident motor vehicle or commercial motor vehicle,
15 a state-operated public boating access site designated under
16 section 78105(2) without a valid pass affixed to the lower right-
17 hand corner of the windshield. A seasonal pass shall be affixed
18 permanently for the season.

19 (2) Subject to subsection (4), the operator of a resident
20 motor vehicle shall not enter a state-operated public boating
21 access site designated under section 78105(2) with the resident
22 motor vehicle unless the recreation passport fee has been paid **OR**
23 **IS CONSIDERED TO HAVE BEEN PAID** for that motor vehicle **AS PROVIDED**
24 **IN SECTION 805 OF THE MICHIGAN VEHICLE CODE, 1949 PA 300, MCL**
25 **257.805**. Payment of the recreation passport fee authorizes entry
26 into all state parks and recreation areas and designated state-
27 operated public boating access sites until expiration of the motor

1 vehicle registration.

2 (3) Subject to subsection (4), if the secretary of state
3 issues registration tabs or stickers as described in section 805 of
4 the Michigan vehicle code, 1949 PA 300, MCL 257.805, the operator
5 of a resident motor vehicle shall not enter a designated state-
6 operated public boating access site with the resident motor vehicle
7 unless the resident motor vehicle has a registration tab or sticker
8 marked as provided under that section to show that the recreation
9 passport fee has been paid **OR IS CONSIDERED TO HAVE BEEN PAID AS**
10 **PROVIDED IN THAT SECTION.**

11 (4) Subsections (1) to (3) do not apply under any of the
12 following circumstances:

13 (a) If the motor vehicle is used in the operation or
14 maintenance of the public boating access site, is an emergency
15 motor vehicle, is a state-owned or law enforcement motor vehicle,
16 or is a private motor vehicle being operated on official state
17 business.

18 (b) If the motor vehicle is registered under section 803e(1)
19 of the Michigan vehicle code, 1949 PA 300, MCL 257.803e, and is
20 exempt under section 803e(6) of the Michigan vehicle code, 1949 PA
21 300, MCL 257.803e, from the registration tax, or if the motor
22 vehicle is registered under section 217d or 803f of the Michigan
23 vehicle code, 1949 PA 300, MCL 257.217d and 257.803f.

24 (c) If and to the extent the department waives the
25 requirements for department-sponsored events or other circumstances
26 as determined by the director or the director's designee.

27 (5) A person who violates subsection (1), (2), or (3) is

1 responsible for a state civil infraction and may be ordered to pay
2 a civil fine of not more than \$100.00. A person shall not be cited
3 for a violation of both subsections (2) and (3) for the same
4 incident.

5 (6) In any proceeding for the violation of this part or a rule
6 promulgated under this part, if a motor vehicle is found parked in
7 a designated state-operated public boating access site, the
8 registration plate displayed on the motor vehicle constitutes prima
9 facie evidence that the owner of the motor vehicle was the person
10 who parked or placed it at the location where it was found.

11 Enacting section 1. This amendatory act takes effect 90 days
12 after the date it is enacted into law.

13 Enacting section 2. This amendatory act does not take effect
14 unless Senate Bill No. ____ or House Bill No. 4380 (request no.
15 01969'17) of the 99th Legislature is enacted into law.
