

# HOUSE BILL No. 4603

May 11, 2017, Introduced by Reps. Howrylak, Wittenberg, Gay-Dagnogo, Lucido, Hoadley, Pagan, Geiss and Sabo and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled  
"Public health code,"  
(MCL 333.1101 to 333.25211) by adding sections 16112 and 20135.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           SEC. 16112. A HEALTH PROFESSIONAL LICENSED, REGISTERED, OR  
2 OTHERWISE AUTHORIZED TO ENGAGE IN A HEALTH PROFESSION UNDER THIS  
3 ARTICLE SHALL COMPLY WITH SECTION 20135. A HEALTH PROFESSIONAL WHO  
4 VIOLATES SECTION 20135 IS SUBJECT TO ANY PENALTY, REMEDY, OR  
5 ADMINISTRATIVE SANCTION APPLICABLE TO A VIOLATION OF THIS ARTICLE.

6           SEC. 20135. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION,  
7 A HEALTH CARE PROVIDER SHALL NOT REFUSE TO PROVIDE HEALTH CARE  
8 SERVICES OR SUPPLIES TO A PATIENT BASED SOLELY ON THE PATIENT'S  
9 REFUSAL TO ALLOW THE HEALTH CARE PROVIDER TO PHOTOCOPY OR SCAN HIS  
10 OR HER DRIVER LICENSE OR MICHIGAN PERSONAL IDENTIFICATION CARD.  
11 THIS SECTION DOES NOT PROHIBIT A HEALTH CARE PROVIDER FROM VIEWING

1 THE LICENSE OR CARD TO VERIFY THE PATIENT'S IDENTITY OR FROM  
2 CAPTURING DATA FROM THE LICENSE OR CARD FOR THE HEALTH CARE  
3 PROVIDER'S DATABASE.

4 (2) AS USED IN THIS SECTION, "HEALTH CARE PROVIDER" MEANS ANY  
5 OF THE FOLLOWING:

6 (A) A HEALTH PROFESSIONAL LICENSED, REGISTERED, OR OTHERWISE  
7 AUTHORIZED TO ENGAGE IN A HEALTH PROFESSION UNDER ARTICLE 15.

8 (B) A HEALTH FACILITY OR AGENCY LICENSED OR CERTIFIED UNDER  
9 THIS ARTICLE.
