May 30, 2017, Introduced by Rep. Lilly and referred to the Committee on Government Operations.

A bill to amend 1986 PA 268, entitled

"Legislative council act,"

(MCL 4.1101 to 4.1901) by adding sections 502 and 602.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 502. (1) THE SENATE FISCAL AGENCY SHALL PREPARE, FOR EACH
- 2 BILL ASSIGNED TO A STANDING COMMITTEE OF THE SENATE, A FISCAL NOTE
- 3 THAT CONTAINS BOTH OF THE FOLLOWING:
  - (A) A DESCRIPTION AND AN ACCOUNTING OF HOW THE LEGISLATION WOULD AFFECT COSTS OR REVENUES FOR THIS STATE.
  - (B) A DESCRIPTION AND AN ACCOUNTING OF HOW THE LEGISLATION WOULD AFFECT COSTS OR REVENUES FOR LOCAL UNITS OF GOVERNMENT.
- 8 (2) BEFORE A VOTE BY A STANDING COMMITTEE, THE SENATE FISCAL 9 AGENCY SHALL DISTRIBUTE THE FISCAL NOTE PREPARED UNDER SUBSECTION
