July 12, 2017, Introduced by Reps. Jones and Kosowski and referred to the Committee on Military and Veterans Affairs.

A bill to amend 1939 PA 280, entitled "The social welfare act,"

(MCL 400.1 to 400.119b) by adding section 17a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 17A. BY NOT LATER THAN 180 DAYS AFTER THE EFFECTIVE DATE
- 2 OF THE AMENDATORY ACT THAT ADDED THIS SECTION, THE DEPARTMENT, IN
- 3 CONSULTATION WITH THE DEPARTMENT OF MILITARY AND VETERANS AFFAIRS,
 - SHALL DO BOTH OF THE FOLLOWING:
- 5 (A) CONDUCT A STUDY TO IDENTIFY MENTAL HEALTH PROGRAMS AND
 - SUICIDE PREVENTION PROGRAMS AND SERVICES AVAILABLE THROUGH VARIOUS
- 7 STATE AGENCIES, COMMUNITY ORGANIZATIONS, AND OTHER NONPROFIT
- 8 ENTITIES TO VETERANS AND MEMBERS OF THE ARMED FORCES IN THIS STATE.

- 1 (B) MAKE RECOMMENDATIONS TO ANY STATE AGENCY, COMMUNITY
- 2 ORGANIZATION, OR OTHER NONPROFIT ENTITY IDENTIFIED IN SUBDIVISION
- 3 (A) CONCERNING ALLOCATION OF ANY AVAILABLE RESOURCES OF THAT STATE
- 4 AGENCY, COMMUNITY ORGANIZATION, OR OTHER NONPROFIT ENTITY.
- 5 (2) BY NOT LATER THAN 180 DAYS AFTER THE EFFECTIVE DATE OF THE
- 6 AMENDATORY ACT THAT ADDED THIS SECTION, THE DEPARTMENT, IN
- 7 CONSULTATION WITH THE DEPARTMENT OF MILITARY AND VETERANS AFFAIRS,
- 8 SHALL REPORT THE FINDINGS OF THE STUDY DESCRIBED IN SUBSECTION
- 9 (1) (A) TO THE SENATE AND HOUSE STANDING COMMITTEES HAVING
- 10 JURISDICTION OVER ISSUES PERTAINING TO MILITARY AND VETERANS
- 11 AFFAIRS AND ISSUES PERTAINING TO HEALTH MATTERS.
- 12 Enacting section 1. This amendatory act takes effect 90 days
- 13 after the date it is enacted into law.
