THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3A. (1) BEGINNING OCTOBER 1, 2017, IF THE LOWEST
- 2 RESPONSIVE AND RESPONSIBLE BIDDER ON A CONTRACT FOR GOODS OR
- 3 SERVICES WITH A LOCAL UNIT IS NOT A MICHIGAN BUSINESS, THEN ALL
- 4 BIDDERS ON THAT CONTRACT THAT ARE MICHIGAN BUSINESSES HAVE 30 DAYS
- 5 TO RESUBMIT THEIR BIDS TO MATCH OR BEAT THE BID FROM THE BIDDER
- 6 THAT IS NOT A MICHIGAN BUSINESS. IF ONLY 1 MICHIGAN BUSINESS THAT
- 7 BID ON THE CONTRACT RESUBMITS A BID UNDER THIS SUBSECTION THAT
- 8 MATCHES OR BEATS THE SUCCESSFUL BID FROM THE BIDDER THAT IS NOT A
 - MICHIGAN BUSINESS, THE LOCAL UNIT SHALL ENTER INTO THE CONTRACT
