- 3 BALLOT QUESTION PETITION PROPOSING A CONSTITUTIONAL AMENDMENT,
- 4 INITIATION OF LEGISLATION, OR REFERENDUM OF LEGISLATION, THAT
- 5 ORGANIZATION SHALL DO BOTH OF THE FOLLOWING:
 - (A) REGISTER THE ORGANIZATION WITH THE SECRETARY OF STATE.
 - (B) MAINTAIN A RECORD OF EACH INDIVIDUAL EMPLOYED BY THAT
